

Detective Supervisor: Organized Crime Task Force (OCTF) – SYRACUSE

The Office of the Attorney General is seeking qualified candidates for a Detective Supervisor position located in the Organized Crime Task Force (OCTF) in Syracuse, NY. Candidates should be hard-working, motivated, and committed to public service on behalf of the people of the State of New York.

Under the direct supervision of the Commanding Officer and the Executive Officer for the OCTF Unit, and in their absence, the Detective Supervisor will be responsible for the supervision of investigatory personnel who conduct a variety of criminal investigations. The Detective Supervisor will provide the first level of review on administrative matters such as time and attendance, expense accounts, state vehicle usage and inspection, training, and overtime approval for unit members, as well as evaluating the performance of the detectives assigned to the unit on a quarterly and annual basis and taking appropriate remedies. The Supervisor will also oversee and direct criminal investigations, case management, staff assignments and will confer with the Commanding Officer and Executive Officer on case matters, as well as personnel issues.

Minimum Qualifications:

- At least 10 years of law enforcement/investigative experience; to include 5 years of police supervision and/or 5 years in a relative leadership role.
- Ability to effectively manage multiple investigations in a variety of disciplines.
- Extensive experience conducting physical surveillance, including electronic eavesdropping.
- Experience conducting criminal investigations including investigating organized crime activity.
- Experience working as an undercover or conducting undercover investigations.
- Experience conducting investigations involving gang activity, narcotics, and illegal firearms.
- Experience conducting undercover surveillance utilizing electronic recording devices.
- Excellent interview skills.
- Experience writing and reviewing case reports.
- Experience coordinating field operations such as search and arrest warrants.
- Experience as an affiant on search warrants and eavesdropping warrants and knowledgeable of the criteria required to obtain same.
- Experience working on a task force.
- Experience testifying at Grand Juries in state and federal jurisdictions.
- A demonstrated cross-cultural competence.
- Established contacts within the law enforcement community in the greater Capital District.
- Must have current NYS basic police school certification.
- Must have the ability to drive a vehicle and possess a valid NYS driver's license.
- The Public Officer's Law requires that police officers at the OAG be citizens of the United States and reside in New York State.

Preferred qualification:

- Bachelor's Degree or higher from an accredited college or university.
