**COUNT ONE**

THE GRAND JURY, by this indictment, accuses the defendant, SAMUEL NEBEDUM of the crime of BRIBE RECEIVING IN THE SECOND DEGREE, in violation of Penal Law §200.11, committed as follows:

Defendant SAMUEL NEBEDUM, between on or about January 1, 2010 and October 31, 2018, in the county of Queens and elsewhere, being a public servant, solicited, accepted, or agreed to accept any benefit valued in excess of ten thousand dollars from another person upon an agreement or understanding that his or her vote, opinion, judgment, action, decision, or exercise of discretion as a public servant would thereby be influenced.

**COUNT TWO**

AND THE GRAND JURY, by this indictment, accuses the defendant, SAMUEL NEBEDUM of the crime of BRIBE RECEIVING IN THE THIRD DEGREE, in violation of Penal Law §200.10 committed as follows:

Defendant SAMUEL NEBEDUM, between on or about January 1, 2010 and October 31, 2018, in the county of Queens and elsewhere, being a public servant, solicited, accepted, or agreed to accept any benefit from another person upon an agreement or understanding that his or her vote, opinion, judgment, action, decision, or exercise of discretion as a public servant would thereby be influenced.

**COUNT THREE**

AND THE GRAND JURY, by this indictment, accuses the defendant, SAMUEL NEBEDUM of the crime of OFFERING A FALSE INSTRUMENT FOR FILING IN THE FIRST DEGREE, in violation of Penal Law §175.35(1) committed as follows:

Defendant SAMUEL NEBEDUM, between on or about August 10, 2017 and on or about September 30, 2017, in the county of Queens and elsewhere, knowing that a written instrument, a New York City Department of Environmental Protection Inspection Report for a premise at 54 Lott Avenue, contained a false statement or

false information, and with intent to defraud the state or any political subdivision, public authority or public benefit corporation of the state, he offered or presented it to a public office, public servant, public authority, or public benefit corporation, with the knowledge or belief that it would be filed with, registered or recorded in or otherwise become a part of the records of such public office, public servant, public authority or public benefit corporation, to wit, the New York City Department of Environmental Protection located at 59-17 Junction Boulevard, Queens, New York.

**COUNT FOUR**

AND THE GRAND JURY, by this indictment, accuses the defendant, SAMUEL NEBEDUM of the crime of OFFICIAL MISCONDUCT, in violation of Penal Law §195.00(1), committed as follows:

Defendant, SAMUEL NEBEDUM, in the county of Queens and elsewhere, being a public servant, between on or about January 1, 2010 and October 31, 2018, with intent to obtain a benefit or deprive another person of a benefit, he committed an act relating to his office but constituting an unauthorized exercise of his official functions, knowing that such act is unauthorized.


**COUNT FIVE**

AND THE GRAND JURY, by this indictment, accuses the defendant, SAMUEL NEBEDUM of the crime of OFFICIAL MISCONDUCT, in violation of Penal Law §195.00(2), committed as follows:

Defendant, SAMUEL NEBEDUM, in the county of Queens and elsewhere, being a public servant, between on or about January 1, 2010 and October 31, 2018, with intent to obtain a benefit or deprive another person of a benefit, he knowingly refrained from performing a duty which was imposed upon him by law or was clearly inherent in the nature of his office.
