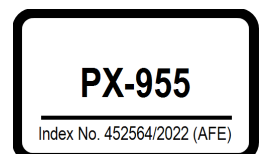

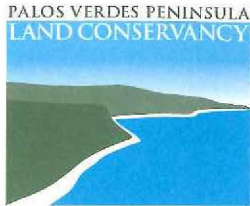


Gifts like yours help the Conservancy achieve many important goals in the coming year:
