# AMENDMENT TO AGREEMENT OF TRUST

THIS AMENDMENT, dated this \_\_\_\_\_ day of January, 2021, to the Agreement of Trust dated April 7, 2014, of DONALD J. TRUMP, of Palm Beach, Palm Beach County, Florida, as Settlor and Trustee,

### WITNESETH:

WHEREAS, on April 7, 2014, DONALD J. TRUMP, as Settlor and Trustee, entered into an Agreement of Trust;

WHEREAS, under subparagraph (1) of Paragraph B of Article SECOND of said Agreement of Trust, Settlor reserved the right to amend or revoke said Agreement of Trust by written instrument specifically referring to said Agreement of Trust signed by Settlor and delivered to the Trustees of said Agreement of Trust;

WHEREAS, on January 11, 2017, Settlor amended said Agreement of Trust in part, reserving his right to amend or revoke said Agreement of Trust under subparagraph (1) of Paragraph B of Article SECOND of said Agreement of Trust;

WHEREAS, on January 17, 2017, Settlor amended said Agreement of Trust in part, creating the Presidential Trust to be governed by the provisions of Article FIRST-A of said Agreement of Trust and appointing Settlor's son, Donald J. Trump, Jr., as Trustee of the Presidential Trust and Allen Weisselberg as Business Trustee of the Presidential Trust, but reserving his right to amend or revoke said Agreement of Trust (other than the Presidential Trust under Article FIRST-A of said Agreement of Trust)

WHEREAS, pursuant to Article TWENTIETH of said Agreement of Trust, if for any reason Settlor shall cease to serve as Trustee, Allen Weisselberg shall become Trustee of each trust under said Agreement of Trust, other than of the Presidential Trust and any trust created thereunder, and each of Settlor's wife, Melania Trump, and children, Donald J. Trump, Jr., Ivanka M. Trump, and Eric F. Trump, shall become Special Trustees of each such trust;

WHEREAS, effective as of January 19, 2017, Donald J. Trump resigned as Trustee under said Agreement of Trust;

WHEREAS, Allen Weisselberg accepted his appointment as Trustee under said Agreement of Trust, other than of the Presidential Trust and any trust created thereunder, as of January 19, 2017;

WHEREAS, Donald J. Trump, Jr. accepted his appointment as Trustee of the Presidential Trust on January 19, 2017, and Allen Weisselberg accepted his appointment as Business Trustee of the Presidential Trust on January 19, 2017 (the "Presidential Trust Trustees");

WHEREAS, Donald J. Trump, Jr. is the Trustee of the Presidential Trust and Allen Weisselberg is the Business Trustee of the Presidential Trust and the Trustee under said Agreement of Trust, other than the Presidential Trust and any trust created thereunder;

WHEREAS, on May 12, 2017, Eric F. Trump, in his capacity as Agent for Donald J. Trump under Power of Attorney New York Statutory Short Form dated as of -2-

that are either not contemplated under said Article FIRST-A or contemplated but not adequately or practically addressed therein, (ii) the Presidential Trust Trustees unanimously consent to such amendment after consultation with the Advisory Board and (iii) the Ethics Advisor confirms that the proposed amendment does not violate the Ethics Standard, as defined under said Article FIRST-A; and

WHEREAS, the Presidential Trust Trustees now wish to amend Article

FIRST-B after consultation with the Advisory Board and confirmation that the proposed amendment does not violate the Ethics Standard.

NOW, THEREFORE, the Presidential Trust Trustees hereby amend Article FIRST-B of the Agreement of Trust in part as follows:

FIRST: The Presidential Trust Trustees hereby revoke Section TWO of Article FIRST-B of said Agreement of Trust and replace it with the following Section TWO of said Article FIRST-B:

#### "SECTION TWO

Initial and Successor Trustees; Disposition of Trust Property

- A. Initial and Successor Trustees.
- (1) Donald J. Trump, Jr. and Allen Weisselberg shall serve as initial Trustees of the trust.
- (2) On the date that I permanently cease to serve as

  President of the United States of America, Donald J. Trump, Jr. and Allen

  Weisselberg shall cease to serve as Trustees and I shall serve as Trustee of

May 11, 2017, amended said Agreement of Trust, creating the HWA LP Subtrust to be governed by the provisions of Articles FIRST-A and FIRST-B of said Agreement of Trust, but reserving Settlor's right to amend or revoke said Agreement of Trust (other than the Presidential Trust and the HWA LP Subtrust under Articles FIRST-A and FIRST-B of said Agreement of Trust) under subparagraph (1) of Paragraph B of Article SECOND of said Agreement of Trust;

WHEREAS, on August 29, 2019, Settlor amended said Agreement of Trust in part;

WHEREAS, on November 10, 2020, Settlor (i) revoked those amendments to said Agreement of Trust dated January 11, 2017 and August 29, 2019, (ii) ratified, confirmed and republished those amendments to said Agreement of Trust dated January 17, 2017 and May 12, 2017, and (iii) amended said Agreement of Trust in its entirety, with the exception of Articles FIRST-A and FIRST-B of said Agreement of Trust, reserving his right to amend or revoke said Agreement of Trust under Subarticle C of Article TENTH of said Agreement of Trust; and

WHEREAS, on January 15, 2021, Settlor amended said Agreement of Trust in part;

WHEREAS, pursuant to Subsection F and Paragraph 1 of Subsection G of Section SEVEN of Article FIRST-A of the Agreement of Trust, which governs the HWA LP Subtrust pursuant to Article FIRST-B of the Agreement of Trust, Article FIRST-A may be amended by the Presidential Trust Trustees if (i) such amendment is necessary or desirable for administrative reasons, as determined by the Presidential Trust Trustees,

- (3) No successor Trustee (other than me or any of my children, Donald J. Trump, Eric F. Trump or Ivanka M. Trump) shall serve without the prior written consent of the general partner of each Company whose interests are owned by the trust.
- (4) Subject to paragraphs (2) and (3) of this Subsection A, on the date that I permanently cease to serve as President of the United States of America, the provisions of Article THIRTEENTH hereof shall apply to the trust.
  - B. <u>Disposition of Trust Property During Presidency</u>.

Until I permanently cease to serve as President of the United States of America, Trustees shall pay such part or all of the net income and/or principal of the trust for my exclusive benefit as set forth in the Presidential Trust under Article FIRST-A hereof.

- C. <u>Disposition of Trust Property Following Presidency</u>.

  On the date that I permanently cease to serve as President of the United States of America, the trust shall be administered and distributed pursuant to the terms of Subarticle A of Article SECOND hereof.
  - D. <u>Termination and Disposition of Trust Property</u>.

Unless sooner terminated by payments of principal as hereinabove provided, the trust shall terminate upon the earlier of (i) the date of my death and (iii) the date my Trustees receive a written instrument of revocation that has been signed and acknowledged by me. Upon

termination, all remaining property shall be transferred by my Trustees to the Trustees of my Revocable Trust to be administered and distributed pursuant to the provisions of Article SECOND hereof or as I may otherwise direct by written instrument of revocation that has been signed and acknowledged by me.

SECOND: In all other respects not inconsistent herewith, the Presidential

Trust Trustees hereby ratify said Agreement of Trust, as amended.
