

RIDER ADDING ADDITIONAL INDEMNITOR TO GENERAL AGREEMENT OF INDEMNITY

DATE OF GIA: October 22, 2009

DATE OF RIDER: January 17, 2017

This Rider shall be attached to and incorporated into the General Agreement of Indemnity, dated above (the "Agreement of Indemnity") which has been executed by Donald J. Trump, identified as the "Indemnitor" in the General Agreement of Indemnity and others as Indemnitors (individually and collectively hereinafter referred to as the "Current Indemnitors" in this Rider) on behalf of Surety Zurich American Insurance Company and its Subsidiaries and Affiliates ("Surety").

WHEREAS the Current Indemnitors executed the Agreement of Indemnity on behalf of Surety; and

WHEREAS Current Indemnitors and DJT Holdings LLC (the "Additional Indemnitor(s)") desire for Additional Indemnitor(s) to be added to the Agreement of Indemnity as named Indemnitor(s) under the Agreement of Indemnity; and

WHEREAS Surety requires that Additional Indemnitor(s) confirm their indemnity obligations to Surety as a named Indemnitor(s) under the Agreement of Indemnity by executing this Rider to the Agreement of Indemnity in consideration for Surety considering further surety credit on behalf of The Trump Organization.

Therefore, it is understood and agreed that:

- 1. The Agreement of Indemnity is modified to add DJT Holdings LLC, 725 Fifth Avenue, New York, NY 10022 as Indemnitor(s).
- 2. The Additional Indemnitor(s) unconditionally acknowledges, accepts, assumes and undertakes all indemnity obligations to Surety arising from or related to the Agreement of Indemnity, jointly and severally with the Current Indemnitors.
- 3. Said addition of Additional Indemnitor(s) to the Agreement of Indemnity shall be immediately effective as of the date of this Rider, in accordance with the terms and conditions of the Agreement of Indemnity, for all Bonds executed or procured to be executed by Surety (regardless of the date on which the Bond(s) were issued) and for all past, present and future obligations and liabilities of Current Indemnitors, other Indemnitors and/or Additional Indemnitor(s) to Surety under the Agreement of Indemnity.
- 4. Nothing in this Rider shall waive, amend or affect the terms and conditions contained in the Agreement of Indemnity, other than as indicated above.
- 5. This Rider shall be attached to and shall form a part of the Agreement of Indemnity, which is incorporated into this Rider by reference.
