THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendants, NORBERTO PENA BRITO, JOSE LEBRON PIMENTEL,

DARIBERTO FERNANDEZ PEREZ, HECTOR RIVERA, JESUS CABRAL, WILLY ABREU MARTINEZ, and ABDUL KHAN, each aiding and acting in concert with each other and others both known and unknown to the grand jury, of the crime of CONSPIRACY IN THE FOURTH DEGREE, in violation of § 105.10(1) of the Penal Law of the State of New York, committed as follows:

From on or about and between the March 6, 2020 and October 8, 2020, in Bronx County, New York County, Westchester County, and elsewhere in the State of New York, with intent that conduct constituting a felony be performed, that felony being the crime of CRIMINAL POSSESSION OF STOLEN PROPERTY IN THE SECOND DEGREE, a Class C felony, in violation of § 165.52 of the Penal Law of the State of New York, the defendants

did knowingly and intentionally agree with one or more persons to engage in or cause the performance of such conduct.

PREAMBLE

It was the purpose of this conspiracy to steal, transport, possess, alter, and sell vehicles, valued in excess of fifty thousand dollars, with intent to benefit themselves or persons other than the owner thereof, from locations in Bronx County, New York County, Westchester County, and elsewhere in the State of New York, and to collect the proceeds from those stolen property transactions.

It was part of this conspiracy for NORBERTO PENA BRITO, JOSE LEBRON PIMENTEL,

DARIBERTO FERNANDEZ PEREZ, and HECTOR RIVERA, to steal, transport, and possess stolen vehicles, valued in excess of fifty thousand dollars, from locations in Bronx County, New York County, Westchester County, and elsewhere in the State of New York.

It was part of this conspiracy for NORBERTO PENA BRITO, JOSE LEBRON PIMENTEL,

DARIBERTO FERNANDEZ PEREZ, HECTOR RIVERA, and JESUS CABRAL to alter stolen vehicles, valued in excess of fifty thousand dollars, to facilitate their resale.

It was part of this conspiracy for WILLY ABREU MARTINEZ and ABDUL KHAN to purchase and possess stolen vehicles, valued in excess of fifty thousand dollars.

It was also part of the conspiracy for members of the conspiracy to communicate with each other and others over cellular telephones.

OVERT ACTS

In furtherance of the conspiracy and to affect the objects thereof, from on or about and between March 6, 2020 and December 22, 2020, the following overt acts, among others, were committed:

- 1. On or about April 19, 2020 at approximately 12:35 a.m., NORBERTO PENA BRITO engaged in a phone conversation with during which NORBERTO PENA BRITO stated in sum and substance: "I'll park the one, and then we'll go get the other one... I'm going to pick you up so get ready".
- 2. On or about April 21, 2020 at approximately 1:54 p.m., NORBERTO PENA BRITO engaged in a phone conversation with DARIBERTO FERNANDEZ PEREZ, during which DARIBERTO FERNANDEZ PEREZ stated in sum and substance: "I will connect it, because remember that car is standard. If you want, I will connect it, and I'll stay in the car, and you wait outside. The machine reaches from outside."
- 3. On or about April 28, 2020 at approximately 9:33 p.m., NORBERTO PENA BRITO engaged in a phone conversation with DARIBERTO FERNANDEZ PEREZ, during which NORBERTO PENA BRITO stated in sum and substance: "That Type R... we have to wait until they moved it to the back block or wherever, right? ... Let's see if they leave it there tomorrow. We will go tomorrow night and take it."
- 4. On or about April 29, 2020 at approximately 5:15 p.m., NORBERTO PENA BRITO engaged in a phone conversation with JOSE LEBRON PIMENTEL, during which JOSE LEBRON PIMENTEL stated in sum and substance: "We checked all around and it does not have anything. It has a box there, but I'm going to disconnect it when I get there and disconnect the battery and leave it there a month more or less. ... Take it out or disconnect it around here, and then take it there, because it will save the last address that it was left at."
- 5. On or about April 29, 2020 at approximately 6:03 p.m., NORBERTO PENA BRITO transported a white 2019 Yukon Denali, bearing Colorado plate QZP722, to Pantoja's Parking Garage located at 1962 Crotona Parkway in Bronx County.

- 6. On or about May 7, 2020 at approximately 3:53 p.m., NORBERTO PENA BRITO engaged in a phone conversation with JESUS CABRAL, during which NORBERTO PENA BRITO stated in sum and substance: "I have at least four things for you to do... You can do whatever you can and come back tomorrow."
- 7. On or about May 7, 2020 between 4:20 p.m. and 5:58 p.m., JESUS CABRAL altered the windshields of four vehicles.
- 8. On or about May 7, 2020 at approximately 5:53 p.m., altered the public Vehicle Identification Number on a gray Honda CR-V.
- 9. On or about May 9, 2020 at approximately 6:51 p.m., NORBERTO PENA BRITO engaged in a phone conversation with WILLY ABREU MARTINEZ, during which NORBERTO PENA BRITO stated in sum and substance: "There's two that I have now. There's the white one and the 2019 CR-V... It's in the parking lot, come get it so I don't keep paying for parking, take it over there."
- 10. On or about May 9, 2020 at approximately 8:34 p.m., WILLY ABREU MARTINEZ was present at 455 East 180th Street in Bronx County and possessed a white 2016 Honda CR-V.
- 11. On or about May 15, 2020 at approximately 4:40 p.m., DARIBERTO FERNANDEZ PEREZ and HECTOR RIVERA altered the windshield of a black Honda Ridgeline.
- 12. On or about May 16, 2020 at approximately 12:38 p.m., NORBERTO PENA BRITO engaged in a phone conversation with DARIBERTO FERNANDEZ PEREZ, during which NORBERTO PENA BRITO stated in sum and substance: "Before you glue, begin to glue them, compare it with the sticker in the front to make sure the numbers are exactly the same. To make sure they match and we didn't make a mistake."

- 13. On or about June 9, 2020 at approximately 6:25 p.m., ABDUL KHAN engaged in a phone conversation with NORBERTO PENA BRITO, during which ABDUL KHAN stated in sum and substance: "Those cars that you said have no titles, I want to buy one for myself, understand? ... I'll take that one for me, and then when the MDX come in I'll put it for sale, understand. ... I'll get a temporary, and in like a month the title will arrive. Then you'll give me the title."
- 14. On or about June 13, 2020 at approximately 7:31 p.m., WILLY ABREU MARTINEZ engaged in a phone conversation with NORBERTO PENA BRITO, during which WILLY ABREU MARTINEZ stated in sum and substance: "What's the deal with the BMW? ...Call and let me know the deal and the price."
- 15. On or about June 30, 2020 at approximately 3:33 p.m., NORBERTO PENA BRITO,

 and JOSE LEBRON PIMENTEL, possessing a gray BMW 740, met with ABDUL KHAN in the vicinity of 495 East 180th Street in Bronx County.
- 16. On or about July 16, 2020 at approximately 3:07 p.m., NORBERTO PENA BRITO sent the following text message to phone number (347) 957-5002:

"M158 Acura | L226 Honda | L532 CRV | K988 Civic"

- 17. On or about the July 25, 2020, NORBERTO PENA BRITO, DARIBERTO FERNANDEZ PEREZ, and HECTOR RIVERA possessed a blue 2018 Honda Civic, Vehicle Identification Number ("VIN") 2HGFC2F75JH569720.
- 18. On or about the July 25, 2020, NORBERTO PENA BRITO, DARIBERTO FERNANDEZ PEREZ, and HECTOR RIVERA possessed a white 2018 Honda CR-V, VIN 2HKRW2H59JH647258.

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendants, NORBERTO PENA BRITO, JOSE LEBRON PIMENTEL, and LETICIA SALDIVAR, each aiding and acting in concert with each other and others both known and unknown to the grand jury, of the crime of **CONSPIRACY IN THE FIFTH DEGREE**, in violation of § 105.05(1) of the Penal Law of the State of New York, committed as follows:

From on or about and between May 29, 2020 and August 28, 2020, in Bronx County, and elsewhere in the State of New York, and the State of Pennsylvania, with intent that conduct constituting a felony be performed, that felony being the crime of OFFERING A FALSE INSTRUMENT FOR FILING, a Class D felony, in violation of § 175.35(1) of the Penal Law of the State of New York, the defendants did knowingly and intentionally agree with one or more persons to engage in or cause the performance of such conduct.

PREAMBLE

It was the purpose of this conspiracy to obtain legitimate titles for stolen vehicles by filing fraudulent documents with the Pennsylvania Department of Transportation, in order to facilitate the resale of these stolen vehicles.

It was part of this conspiracy for NORBERTO PENA BRITO and JOSE LEBRON PIMENTEL to steal, transport, alter, and possess stolen vehicles from locations in Bronx County, New York County, Westchester County, and elsewhere in the State of New York, and provide fraudulent Vehicle Identification Numbers and other vehicle information to LETICIA SALDIVAR.

It was part of this conspiracy for LETICIA SALDIVAR to prepare and offer false written instruments for filing to the Pennsylvania Department of Transportation.

It was also part of the conspiracy for members of the conspiracy to communicate with each other and others over cellular telephones.

OVERT ACTS

In furtherance of the conspiracy and to affect the objects thereof, from on or about and between May 29, 2020 and August 28, 2020, the following overt acts, among others, were committed:

- 1. On or about June 9, 2020 at approximately 2:32 p.m., NORBERTO PENA BRITO engaged in a phone conversation with LETICIA SALDIVAR, during which NORBERTO PENA BRITO stated in sum and substance: "I want to know the hours you're open, because I'm planning to head down there from New York. I want to talk in person about registering a few vehicles."
- 2. On or about July 14, 2020 at approximately 11:03 a.m., JOSE LEBRON PIMENTEL engaged in a phone conversation with LETICIA SALDIVAR, during which LETICIA SALDIVAR stated in sum and substance: "you can bring five more".
- 3. On or about July 18, 2020 at approximately 2:27 p.m., JOSE LEBRON PIMENTEL engaged in a phone conversation with a male individual, during which JOSE LEBRON PIMENTEL stated in sum and substance: "Those cars that you have, send me pictures of inside the doors, even for the Cherokee... In Pennsylvania, we have a way to register them and get the title."
- 4. On or about July 20, 2020 at approximately 12:14 p.m., NORBERTO PENA BRITO engaged in a phone conversation with JOSE LEBRON PIMENTEL, during which JOSE LEBRON PIMENTEL stated in sum and substance: "I give her the titles, she will take it to her friends, they flip them. It's not going to fail, because remember that it's coming from a dealer in the same state. They will process it like a normal title, and that's it, like a regular title comes back... What she recommended is that all the cars that we are going to send her to flip should have an inspection with the same miles as the title says. That way, when they run it, they'll have a record with the mileage instead of nothing."

- 5. On or about July 23, 2020 at approximately 5:30 p.m., NORBERTO PENA BRITO, JOSE LEBRON PIMENTEL, and LETICIA SALDIVAR met at Carmela's Multiservice Inc. at 513 West Erie Avenue in Philadelphia, Pennsylvania.
- 6. On or about July 31, 2020 at approximately 4:31 p.m., JOSE LEBRON PIMENTEL engaged in a phone conversation with LETICIA SALDIVAR, during which JOSE LEBRON PIMENTEL stated in sum and substance: "I'm going to pick them up tomorrow. You are going to have to work a little bit today. ...The problem is that until they give me the titles, I can't give you anything, you understand? I didn't have the titles in my hands, and I wanted to verify how many titles were arriving and how many miles to avoid making a mess. ... I sent you the sticker for the Ford, the sticker for the Camry. Look through, it's there. I sent you the sticker for the 2016 and 2017 Accords."
- 7. On or about August 5, 2020 at approximately 7:15 p.m., LETICIA SALDIVAR met with JOSE LEBRON PIMENTEL in the vicinity of 495 East 180th Street, Bronx County.
- 8. On or about August 7, 2020 at approximately 6:18 p.m., JOSE LEBRON PIMENTEL engaged in a phone conversation with LETICIA SALDIVAR, during which JOSE LEBRON PIMENTEL stated in sum and substance: "I will have 20 for you today... I'll give you all the stickers and everything... you're going to give me plates for everything, right?"
- 9. On or about August 12, 2020 at approximately 8:07 p.m., JOSE LEBRON PIMENTEL engaged in a phone conversation with LETICIA SALDIVAR, during which LETICIA SALDIVAR stated in sum and substance: "Yes, I'm just waiting for them to put me in the system when they move from the place. . . Oh no, for that deal I still have to get a place for that one. So, I can work it alone".
- 10. On or about August 13, 2020 at approximately 10:22 p.m., LETICIA SALDIVAR took possession of a white 2020 Acura MDX in the vicinity of 495 East 180th Street, Bronx County.

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendants, NORBERTO PENA BRITO, JOSE LEBRON PIMENTEL, and JESUS CABRAL, each aiding and acting in concert with each other, of committing the crime of CRIMINAL POSSESSION OF STOLEN PROPERTY IN THE SECOND DEGREE, in violation of § 165.52 of the Penal Law of the State of New York, committed as follows:

Said defendants, on or about and between April 1, 2020 and April 24, 2020, in Bronx County and elsewhere inside of the State of New York, knowingly possessed stolen property, with intent to benefit themselves or a person other than the owner thereof, or to impede the recovery by the owner thereof, and the value of the property exceeded fifty thousand dollars, to wit: a 2019 white Acura RDX, VIN 5J8TC2H50KL033678, and a 2019 black Acura MDX, VIN 5J8YD4H03KL005800.

COUNT 4

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendants, NORBERTO PENA BRITO, JOSE LEBRON PIMENTEL,

JESUS CABRAL, and ABDUL KHAN, each aiding and acting in concert with each other, of committing the crime of CRIMINAL POSSESSION OF STOLEN PROPERTY IN THE THIRD DEGREE, in violation of § 165.50 of the Penal Law of the State of New York, committed as follows:

Said defendants, on or about and between April 1, 2020 and May 15, 2020, in Bronx County and elsewhere inside of the State of New York, knowingly possessed stolen property, with intent to benefit themselves or a person other than the owner thereof, or to impede the recovery by the owner thereof, and the value of the property exceeded three thousand dollars, to wit: a 2019 white Acura RDX, VIN 5J8TC2H50KL033678.

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendants, NORBERTO PENA BRITO, JOSE LEBRON PIMENTEL,

JESUS CABRAL, and ABDUL KHAN, each aiding and acting in concert with each other, of committing the crime of UNAUTHORIZED USE OF A MOTOR VEHICLE IN THE FIRST DEGREE, in violation of § 165.08 of the Penal Law of the State of New York, committed as follows:

Said defendants, on or about and between April 1, 2020 and May 15, 2020, in Bronx County and elsewhere inside of the State of New York, knowing that they did not have the consent of the owner, took, operated, exercised control over, rode in, or otherwise used a vehicle, to wit: a 2019 white Acura RDX, VIN 5J8TC2H50KL033678, in the course of or the commission of the following crime: CRIMINAL POSSESSION OF STOLEN PROPERTY IN THE THIRD DEGREE, a class D felony.

COUNT 6

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the

Said defendants, on or about the and between April 1, 2020 and May 15, 2020, in Bronx County and elsewhere inside of the State of New York, knowingly destroyed, covered, defaced, altered, or otherwise changed the form or appearance of a vehicle identification number on a vehicle, to wit: a 2019 white Acura RDX, VIN 5J8TC2H50KL033678.

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendants, NORBERTO PENA BRITO, JOSE LEBRON PIMENTEL, and JESUS CABRAL, each aiding and acting in concert with each other, of committing the crime of ILLEGAL POSSESSION OF A VEHICLE IDENTIFICATION NUMBER, in violation of § 170.70(2) of the Penal Law of the State of New York, committed as follows:

Said defendants, on or about and between April 1, 2020 and May 15, 2020, in Bronx County and elsewhere inside of the State of New York, knowingly possessed a vehicle (to wit: a 2019 white Acura RDX, VIN 5J8TC2H50KL033678), to which was attached a vehicle identification number label, sticker or plate or on which is stamped or embossed a vehicle identification number which has been destroyed, covered, defaced, altered or otherwise changed.

COUNT 8

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendants, NORBERTO PENA BRITO, JOSE LEBRON PIMENTEL, and JESUS CABRAL, each aiding and acting in concert with each other, of committing the crime of SALE OF MOTOR VEHICLE, TRAILER, OR PART THEREOF WITH CHANGED IDENTIFICATION NUMBER, in violation of § 421(3) of the Vehicle and Traffic Law of the State of New York, committed as follows:

Said defendants, on or about and between April 1, 2020 and May 15, 2020, in Bronx County and elsewhere inside of the State of New York, knowingly sold or offered for sale a motor vehicle, trailer, or part thereof (to wit: a 2019 white Acura RDX, VIN 5J8TC2H50KL033678), the original vehicle identification number of which had been destroyed, removed, altered, defaced or so covered as to be effectually concealed.

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendants, NORBERTO PENA BRITO, JOSE LEBRON PIMENTEL,

JESUS CABRAL, and ABDUL KHAN, each aiding and acting in concert with each other, of committing the crime of FALSE STATEMENT; STOLEN VEHICLES, in violation of § 426 of the Vehicle and Traffic Law of the State of New York, committed as

follows:

Said defendants, on or about and between April 1, 2020 and May 15, 2020, in Bronx County and elsewhere inside of the State of New York, possessed a motor vehicle which they knew, or had reason to believe, was stolen, to wit: a 2019 white Acura RDX, VIN 5J8TC2H50KL033678, and the defendants were not officers of the law engaged at the time in the performance of their duties as such officers.

COUNT 10

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendants, NORBERTO PENA BRITO, JOSE LEBRON PIMENTEL,

and JESUS CABRAL, each aiding and acting in concert with each other, of committing the crime of AUTO STRIPPING IN THE THIRD DEGREE, in violation of § 165.09(1) of the Penal Law of the State of New York, committed as follows:

Said defendants, on or about and between April 1, 2020 and May 15, 2020 in Bronx County and elsewhere inside of the State of New York, removed, or intentionally destroyed or defaced any part of a vehicle, other than an abandoned vehicle, to wit: a 2019 white Acura RDX, VIN 5J8TC2H50KL033678, without the permission of the owner.

COUNT 11

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendants, NORBERTO PENA BRITO, JOSE LEBRON PIMENTEL,

ESTEVEZ, and JESUS CABRAL, each aiding and acting in concert with each other, of committing the crime of CRIMINAL POSSESSION OF STOLEN PROPERTY IN THE THIRD DEGREE, in violation of § 165.50 of the Penal Law of the State of New York, committed as follows:

Said defendants, on or about and between April 1, 2020 and May 15, 2020, in Bronx County and elsewhere inside of the State of New York, knowingly possessed stolen property, with intent to benefit themselves or a person other than the owner thereof, or to impede the recovery by the owner thereof, and the value of the property exceeded three thousand dollars, to wit: a 2019 black Acura MDX, VIN 5J8YD4H03KL005800.

COUNT 12

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the

defendants, NORBERTO PENA BRITO, JOSE LEBRON PIMENTEL,

Said defendants, on or about and between April 1, 2020 and April 24, 2020, in Bronx County and elsewhere inside of the State of New York, knowing that they did not have the consent of the owner, took, operated, exercised control over, rode in, or otherwise used a vehicle, to wit: a 2019 black Acura MDX, VIN 5J8YD4H03KL005800, in the course of or the commission of the following crime: CRIMINAL POSSESSION OF STOLEN PROPERTY IN THE THIRD DEGREE, a class D felony.

COUNT 13

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendants, NORBERTO PENA BRITO, JOSE LEBRON PIMENTEL,

, and JESUS CABRAL, each aiding and acting in concert with each other, of committing the crime of FALSE STATEMENT; STOLEN VEHICLES, in violation of § 426 of the Vehicle and Traffic Law of the State of New York, committed as follows:

Said defendants, on or about and between April 1, 2020 and April 24, 2020, in Bronx County and elsewhere inside of the State of New York, possessed a motor vehicle which they knew, or had reason to believe, was stolen, to wit: a 2019 black Acura MDX, VIN 5J8YD4H03KL005800, and the defendants were not officers of the law engaged at the time in the performance of their duties as such officers.

COUNT 14

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendants, NORBERTO PENA BRITO, JOSE LEBRON PIMENTEL, and JESUS CABRAL, each aiding and acting in concert with each other, of committing the crime of AUTO STRIPPING IN THE THIRD DEGREE, in violation of § 165.09(1) of the Penal Law of the State of New York, committed as follows:

Said defendants, on or about and between April 1, 2020 and April 24, 2020, in Bronx County and elsewhere inside of the State of New York, removed, or intentionally destroyed or defaced any part of a vehicle, other than an abandoned vehicle, to wit: a 2019 black Acura MDX, VIN 5J8YD4H03KL005800, without the permission of the owner.

COUNT 15

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendants, NORBERTO PENA BRITO,

and DARIBERTO FERNANDEZ PEREZ, each aiding and acting in concert with each other, of committing the crime of CRIMINAL POSSESSION OF STOLEN PROPERTY IN THE THIRD DEGREE, in violation of § 165.50 of the Penal Law of the State of New York, committed as follows:

Said defendants, on or about and between April 9, 2020 and April 22, 2020, in Bronx County and elsewhere inside of the State of New York, knowingly possessed stolen property, with intent to benefit themselves or a person other than the owner thereof, or to impede the recovery by the owner thereof, and the value of the property exceeded three thousand dollars, to wit: a 2015 urban titanium (brown/gray) Honda CR-V, VIN 2HKRM4H56FH687824.

COUNT 16

Said defendants, on or about and between April 9, 2020 and April 22, 2020, in Bronx County and elsewhere inside of the State of New York, knowing that they did not have the consent of the owner, took, operated, exercised control over, rode in, or otherwise used a vehicle, to wit: a 2015 urban titanium (brown/gray) Honda CR-V, VIN 2HKRM4H56FH687824, in the course of or the commission of the following crime: CRIMINAL POSSESSION OF STOLEN PROPERTY IN THE THIRD DEGREE, a class D felony.

COUNT 17

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendants, NORBERTO PENA BRITO,

CABRAL, each aiding and acting in concert with each other, of committing the crime of FORGERY OF A VEHICLE IDENTIFICATION NUMBER, in violation of § 170.65(1) of the Penal Law of the State of New York, committed as follows:




