Continuing Education Certificates in Law Enforcement, Behavioral Science, or communication skills training, from an accredited training provider such as the NYS Division of Criminal Justice Services. Expertise in Computer Forensics, Financial Crimes, or organized crime investigation. Fluency in a second language.
