The Office of the Attorney General is seeking qualified candidates for a Detective Investigator position located in Buffalo, NY. Candidates should be hard-working, motivated, and committed to public service on behalf of the people of the State of New York.

The role of the OCTF is to conduct complex, long-term investigations into various types of organized criminal activity. The majority of OCTF investigations utilize advanced and specialized investigative techniques such as physical surveillance, court authorized eavesdropping of telephones, businesses, vehicles, and computers, as well as search warrants, which include the use of still and video photography. The nature of the investigations conducted by OCTF includes traditional organized crime - gambling, loan sharking, extortion, and narcotics, among others.

Minimum Qualifications:

- Must have at least ten (10) years of prior law enforcement experience, five (5) of which must have been in an investigative capacity.
- Have current NYS basic police academy certification approved by DCJS or the ability to successfully complete all requirements to obtain NYS basic police academy certification.
- Must possess a valid NYS Driver's License with ability to operate a motor vehicle.
- Extensive experience performing narcotics investigations working with multi-jurisdictional task forces.
- Experience being an affiant on search warrants.
- Experience utilizing surveillance equipment.
- Experience working on cases with OCTF while on a police force.
- Knowledgeable of SYTECH.
- Experience testifying in court.
- Established contacts within the law enforcement community serving Buffalo and the surrounding areas.

The annual salary for this position is \$75,348. This position is overtime eligible. Performance of the duties may require frequent, unscheduled work on evenings and weekends and requires 24/7 availability. This position is in the exempt class, and incumbents serve at the pleasure of the Attorney General.

Candidates from diverse backgrounds are encouraged to apply. The OAG is an equal opportunity employer and is committed to workplace diversity.
