The Office of the Attorney General is seeking qualified candidates for Detective Investigator positions located in the Major Investigations Unit (NYC), within the Investigations Division. Candidates should be hard-working, self-motivated, and committed to public service on behalf of the people of the State of New York.

Under the direct supervision of the Detective Supervisor of the Major Investigations Unit, the Detective Investigators work collaboratively in case-specific investigative teams with Assistant Attorneys General, analysts, and forensic auditors to conduct highly complex criminal and civil investigations, using the highest level of professionalism, judgment, and discretion.

Successful candidates will combine traditional investigative experience and skills with strong communication and interpersonal skills and the ability to work effectively in multi-disciplinary teams.

Minimum Qualifications:

- Must have at least ten (10) years of prior law enforcement investigative experience.
- Have current NYS basic police academy certification approved by DCJS or the ability to successfully complete all requirements to obtain NYS basic police academy certification.
- Must possess strong writing, analytical and organizational skills.
- Demonstrated success in complex criminal investigations.
- Proficiency with computers, common word processing applications, use of search engines, investigative databases, and internet research.
- Must possess a valid NYS Driver's License with ability to operate a motor vehicle.
- The Public Officer's Law requires that police officers at the OAG be citizens of the United States and reside in New York State.

Preferred Qualifications

- Excellent interviewing and interrogation skills.
- Excellent interpersonal communication and writing skills.
- Experience in the following areas:
 - o Conducting complex, long-term investigations.
 - o Participating in undercover operations, conducting surveillance operations and in the use of surveillance technologies.
 - o Investigating complaints of sexual and physical abuse.
 - o Obtaining and executing arrest and search warrants.
 - o Testifying in grand jury and court proceedings.
 - o Effectively conducting and managing multiple investigations.
 - o Investigating financial crimes.
 - o Investigating public corruption.
- Cultural competence to understand and effectively respond to cultural differences for the purpose of
 involvement in undercover operations and/or otherwise to be inserted into investigations and interactions with
 targets across cultures.
- Experience working on a task force.
- Established contacts within the law enforcement community in the greater New York City area.
- The ability to read, write, speak and understand a second language in addition to English (e.g. Spanish, Mandarin, Russian, Korean, etc.) preferred.

Bachelor's degree.

The annual salary for this position is \$77,608. Appointments in New York City receive an additional \$4,000 location pay. This position is overtime eligible. Performance of the duties may require frequent, unscheduled work on evenings and weekends and requires 24/7 availability. This position is in the exempt class, and incumbents serve at the pleasure of the Attorney General.

Candidates from diverse backgrounds are encouraged to apply.
