The Office of the Attorney General is seeking qualified candidates for a Detective Investigator position, within the Major Investigations Unit, located in Poughkeepsie. Candidates should be hard-working, motivated and committed to public service on behalf of the people of the State of New York.

Detective Investigators, under supervision, conduct detailed investigations of the circumstances, facts and conditions connected with complaints and violations of the law, using the highest level of independent judgment and discretion. These are often highly complex and sensitive criminal matters which cross county and state lines. This position also assists the Executive Protection Detail for the Attorney General on an as-needed basis and conducts investigations in a wide variety of criminal cases in various bureaus throughout the Office of the Attorney General.

Minimum Qualifications:

- Must have at least ten (10) years of prior law enforcement experience.
- Have current NYS basic police academy certification approved by DCJS or the ability to successfully complete all requirements to obtain NYS basic police academy certification.
- Experience conducting executive protection operations ensuring the security of high-level officials and other dignitaries.
- Experience in threat assessment, protective intelligence and logistical security planning and travel.
- Familiarization with evacuation routes.
- Experience implementing proper steps to eliminate and/or reduce risks including threats and hazards.
- While this position is assigned to the Poughkeepsie area, the incumbent must be available to travel anywhere the Attorney General travels, at any time.
- Investigative experience in sex-related crimes.
- Experience in surveillance operations.
- Interaction and coordination with other law enforcement agencies.
- Having law enforcement contacts in the Dutchess County and surrounding areas.
- Must possess a valid NYS Driver's License with ability to operate a motor vehicle.
- The Public Officer's Law requires that police officers at the OAG be citizens of the United States and reside in New York State.

Preferred Oualifications:

Bachelor's degree from an accredited college or university.

The annual salary for this position is \$77,608. Appointments in Poughkeepsie receive an additional \$2,000 location pay. This position is overtime eligible. Performance of the duties may require frequent, unscheduled work on evenings and weekends and requires 24/7 availability. This position is in the exempt class, and incumbents serve at the pleasure of the Attorney General.

Candidates from diverse backgrounds are encouraged to apply.
