The Office of the New York State Attorney General's New York City [Appeals and Opinions Bureau](#) is offering a two-year Fellowship in government appellate litigation. The Fellowship is a compensated, full-time position for a college graduate who is considering whether to pursue a career in law or public affairs. **A commitment through June 2028 is required.**

The bureau handles civil appeals by and against the state of New York in all state and federal appellate courts and prepares briefs for an active amicus curiae practice nationwide. Cases cover a wide range of issues, including constitutional and statutory public-law issues, employment, civil rights, torts, the environment, and agency decision-making. We are seeking a bright, dynamic, hard-working, and motivated individual committed to public service. The selected Fellow will work closely with attorneys to prepare court documents and appellate records; finalize briefs, including highly detailed proofreading and cite-checking; organize case files; provide relevant legal and office support; and potentially work on special projects.

Applicants must have a BA or BS degree prior to their start date. Excellent oral and written communication skills, hyper-attention to detail (e.g., proofreading and document production), organizational skills, and the ability to handle multiple tasks under pressure are required. Experience in a legal setting is a plus, but not required as a Fellow will receive extensive training. Availability for weekday overtime is required.

The salary for this position is \$62,745 + \$4,000 in location pay. As an employee of OAG, you will join a team of dedicated individuals who work to serve the people of our state through a wide variety of occupations. We offer a comprehensive New York state benefits package, including paid leave, health, dental, vision, and retirement benefits, and family-friendly policies.  - Provide a sample that is 7-10 pages in length (double-spaced, minimum 12-point type size).
 - The sample must be exclusively your own work and demonstrate your writing and analytical abilities.

- **Reference List**

- Submit a list of three (3) professional references; supervisory references are preferred.
- For each reference, indicate the nature and duration of your relationship.
- Include contact information and email addresses for each reference.
