The Office of the Attorney General is seeking qualified candidates for a Detective Supervisor position located in our Medicaid Fraud Control Unit (MFCU) –New York City office. Candidates should be hard-working, motivated and committed to public service on behalf of the people of the State of New York.

MFCU, the centerpiece of New York's efforts to combat Medicaid provider fraud, is looking for experienced detectives to conduct complex investigations into fraud committed by Medicaid providers and others in the healthcare industry who steal from New York State, those involved in the diversion of prescription narcotics, and to investigate and prosecute abuse and neglect of residents in nursing homes, hospitals, and other residential healthcare facilities.

Minimum Qualifications:

- Must have at least five (5) years of OAG investigative experience or at least ten (10) years of law enforcement with at least five (5) years of law enforcement investigative experience.
- Must have a current NYS basic police academy certification or NYS specialized police investigator certification approved by DCJS or the ability to successfully complete all requirements to obtain such certification.
- Must possess and demonstrate excellent interpersonal communication, analytical, and writing skills.
- Must possess strong leadership skills and a proven record utilizing good judgment.
- Must demonstrate proficiency with computers, common word processing applications, use of search engines, investigative and law enforcement databases and internet research.
- Must have established regional state, local and federal law enforcement contacts.
- Must possess the ability to effectively plan, conduct and manage multiple, long-term, complex investigations in multidisciplinary teams.
- Ability to lead, mentor, and develop investigative personnel while fostering accountability, professionalism, and teamwork.
- Experience investigating white-collar crime, narcotics operations, insurance fraud cases, and electronic crimes.
- Familiarity conducting sensitive, internal investigations.
- Experience providing leadership and direction in complex criminal, civil, and administrative investigations involving healthcare fraud and patient abuse or neglect.
- Ability to demonstrate cultural competency and professionalism in interactions with employees and the public.
- Ability to lead investigations while coordinating effectively with prosecutors, analysts, and external partners.
- Ability to evaluate and monitor performance, proactively address challenges, and support mission accomplishment.
- Ability to work with and effectively coordinate with other law enforcement agencies.
- Must possess and demonstrate an unwavering commitment to professionalism, personal integrity, and ability to uphold the highest levels of confidentiality and ethical standards.
- Must possess a valid NYS Driver's License with ability to operate a motor vehicle.
- The Public Officer's Law requires that police officers at the OAG be citizens of the United States and reside in New York State.

Preferred Qualifications:

- Bachelor's degree from an accredited college.
- Prior supervisory experience, specifically in law enforcement; experience planning and supervising field

- operations, such as surveillance operations and search warrant and arrest warrant operations.
- Demonstrate proficiency in the use of ACISS, writing and reviewing case reports.
- Cultural competence to understand and effectively respond to cultural differences for the purpose of involvement in undercover operations and/or otherwise to be inserted into investigations and interactions with targets across cultures.
- The ability to read, write, speak and understand a second language in addition to English (e.g., Spanish, Mandarin, Russian, Korean, etc.).

The annual salary for this position is \$113,360. Appointments in New York City receive an additional \$4,000 location pay. Performance of the duties may require frequent, unscheduled work on evenings and weekends and requires 24/7 availability. This position is in the exempt class, and incumbents serve at the pleasure of the Attorney General.
