The Office of the Attorney General is seeking qualified candidates for the position of Assistant Chief Investigator for the Medicaid Fraud Control Unit (MFCU) within the Investigations Division. Candidates should be hard-working, motivated, and committed to public service on behalf of the people of the State of New York. This position will be based in New York City.

MFCU, the centerpiece of New York's efforts to combat Medicaid provider fraud, conducts complex investigations into fraud committed by Medicaid providers and others in the healthcare industry who steal from New York State, those involved in the diversion of prescription narcotics, and to investigate and prosecute abuse and neglect of residents in nursing homes, hospitals, and other residential healthcare facilities. Detective Investigators work collaboratively in case specific teams with Assistant Attorneys General, analysts, and forensic auditors to learn how to conduct highly complex criminal and civil investigations, using the highest level of professionalism, judgement, and discretion.

The Assistant Chief Investigator is primarily an administrative position.

Duties performed by the Assistant Chief may include, but are not limited to the following:

- Monitor/Coordinate the MFCU Investigations Unit budget needs.
- Create/Provide innovative ideas, strategies, training, and equipment evaluations to the MFCU Commanding Officer.
- Coordinate MFCU police recruits at academies statewide.
- Serve as fleet manager – evaluate fleet requirements and maintenance, monitor fuel and related expenses – process accidents for MFCU statewide.
- Serve as EJustice contact for the MFCU statewide.
- Function as administrator over multiple investigative database service providers.
- Prepare and present briefings for senior agency management.
- Serve as control officer for undercover identifications and Medicaid cards and serve as liaison to various Social Service, Federal and State agency partners.
- Provide coverage for the MFCU Executive Officer or Commanding Officer as needed.
- CPR-AED Certification upon/after appointment
- Serve as Fire Warden/Assistant Fire warden for office location.
- Management of the MFCU Evidence room and related equipment.

Minimum Qualifications:

- Must have at least ten (10) years of prior law enforcement experience.
- Must have a current NYS basic police academy certification or NYS specialized police investigator certification approved by DCJS or the ability to successfully complete all requirements to obtain such certification.
- At least 5 years of administrative supervisory experience.
- Extensive administrative experience.
- Extensive experience with the EJustice System, Accurint, Clear, EMedny, and Microsoft Office Suite programs.
- Extensive contacts in the law enforcement and social service community throughout New York State.
- Knowledge of/experience with NYS Contract Award and Vendor guidelines.
- Experience in OAG Fleet Management and related contacts.
- Experience in budgeting, purchasing and resource allocation methodology.

- Extensive experience in managing staff of various ranks.
- Excellent interpersonal communication skills.
- Must possess a valid NYS driver's license and have the ability to drive a motor vehicle.
- The Public Officer's Law requires that police officers at the OAG be citizens of the United States and reside in New York State.

Preferred Qualifications:

- A bachelor's degree from an accredited college or university.

The annual salary for this position is \$146,649. Appointments in New York City receive an additional \$4,000 location pay.

Performance of the duties may require frequent, unscheduled work on evenings and weekends and requires 24/7 availability. This position is in the exempt class, and incumbents serve at the pleasure of the Attorney General.
