The Office of the Attorney General is seeking qualified candidates for a Detective Investigator position located in Syracuse, NY. Candidates should be hard-working, motivated, and committed to public service on behalf of the people of the State of New York.

The role of the OCTF is to conduct complex, long-term investigations into various types of organized criminal activity. The majority of OCTF investigations utilize advanced and specialized investigative techniques such as physical surveillance, court authorized eavesdropping of telephones, businesses, vehicles, and computers, as well as search warrants, which include the use of still and video photography. The nature of the investigations conducted by OCTF includes traditional organized crime - gambling, loan sharking, extortion, and narcotics, among others.

Minimum Qualifications:

- Must have at least ten (10) years of prior law enforcement experience.
- Have a current NYS basic police academy certification or NYS specialized police investigator certification approved by DCJS or the ability to successfully complete all requirements to obtain such certification.
- Extensive experience performing undercover work, especially in the pursuit of illegal drugs.
- Experience investigating gangs.
- Experience conducting interrogations.
- Utilizing surveillance equipment.
- Being an affiant on search and eavesdropping warrants.
- Proven ability to cultivate confidential informants.
- Knowledgeable of SYTECH.
- Experience working with OCTF while a member of a police force.
- Having established contacts within the law enforcement community serving Syracuse and the surrounding areas.
- Must possess a valid NYS Driver's License with ability to operate a motor vehicle.
- The Public Officer's Law requires that police officers at the OAG be citizens of the United States and reside in New York State.

The annual salary for this position is \$81,100. This position is overtime eligible. Performance of the duties may require frequent, unscheduled work on evenings and weekends and requires 24/7 availability. This position is in the exempt class, and incumbents serve at the pleasure of the Attorney General.
