**COUNT 1**

THE GRAND JURY OF DUTCHESS COUNTY, by this Indictment, accuses the defendants, **ROMELL HEARN** and **DWAN SCAFE**, of the crime of **OPERATING AS A MAJOR TRAFFICKER**, in violation of Section 220.77(3) of the Penal Law of the State of New York, committed as follows:

Said defendants, acting in concert with each other, on or about and between November 28, 2023, and May 23, 2024, in Dutchess County, as profiteers, did knowingly and unlawfully possess, on one or more occasions within six months or less, a narcotic drug, with intent to sell the same, to wit: cocaine, and such narcotic drug had a total aggregate value of seventy-five thousand dollars or more.

**COUNT 2**

THE GRAND JURY OF DUTCHESS COUNTY, by this Indictment, accuses the defendants, **SHAMIQUE DELAINE**; **JONTE HATCHER a/k/a “DIGGS”** (hereinafter, “**JONTE HATCHER**”); **ROMELL HEARN a/k/a “MEL”** (hereinafter, “**ROMELL**

**HEARN**"); **NICOLE KANE**; **DAQUAN KILLIAN**; and **DWAN SCAFE**, of the crime of **CONSPIRACY IN THE SECOND DEGREE**, in violation of Section 105.15 of the Penal Law of the State of New York, committed as follows:

On or about and between October 24, 2023, and August 29, 2024, in Dutchess County, Ulster County, Westchester County and Orange County, with intent that conduct constituting the crimes of Criminal Sale of a Controlled Substance in the Second Degree, in violation of Section 220.41(1) of the Penal Law of the State of New York, and/or Criminal Possession of a Controlled Substance in the Second Degree, in violation of Section 220.18(1) of the Penal Law of the State of New York, said crimes being class A felonies, be committed, the defendants did knowingly and intentionally agree with each other and with others, known and unknown, to engage in and cause the performance of such conduct as would constitute any of the above-mentioned class A felonies.

#### **PREAMBLE**

It was the purpose of this conspiracy to acquire, possess, with intent to sell, and sell quantities of narcotic drugs, including cocaine and counterfeit oxycodone pills containing fentanyl, in Dutchess County, Ulster County, Westchester County and Orange County.

It was the purpose of this conspiracy to possess controlled substances in amounts of four ounces or more, and to sell controlled substances in amounts of one-half ounce or more in Dutchess County, Ulster County, Westchester County and Orange County, and to collect the proceeds from those controlled substance transactions.

It was the role of **NICOLE KANE** to acquire, possess and supply cocaine and counterfeit oxycodone pills containing fentanyl with **DAQUAN KILLIAN**, **ROMELL HEARN** and **JONTE HATCHER** for resale in Dutchess County, Ulster County, Westchester County and Orange County.

It was the role of **DAQUAN KILLIAN** to acquire, possess and supply counterfeit oxycodone pills containing fentanyl with **NICOLE KANE** for resale in Dutchess County and Ulster County.

It was the role of **ROMELL HEARN** to acquire, possess and supply cocaine and counterfeit oxycodone pills containing fentanyl with **NICOLE KANE** and **DWAN SCAFE** for resale in Dutchess County and Ulster County.

It was the role of **DWAN SCAFE** to acquire, possess and supply cocaine and counterfeit oxycodone pills containing fentanyl with **ROMELL HEARN** for resale in Dutchess County.

It was the role of **JONTE HATCHER** to acquire, possess and supply cocaine and counterfeit oxycodone pills containing fentanyl with **NICOLE KANE** and others for resale in Dutchess County, Ulster County, Westchester County and Orange County.

It was the role of **SHAMIQUE DELAINE** to possess and supply cocaine for resale in Dutchess County.

It was also part of the conspiracy for members of the conspiracy to communicate with each other and others over cellular telephones using coded terminology and speaking in a guarded, cryptic manner.

### **OVERT ACTS**

In furtherance of said conspiracy and to achieve the objects thereof, and during the course thereof, the following overt acts, among others, were committed:

1. On or about October 24, 2023, in the vicinity of 75 Mackey Road, Highland, New York, in Ulster County, **NICOLE KANE** provided a quantity of counterfeit oxycodone pills containing fentanyl to an individual known to the Grand Jury, in exchange for a sum of United States currency.

2. On or about October 26, 2023, in the vicinity of 75 Mackey Road, Highland, New York, in Ulster County, **NICOLE KANE** provided a quantity of counterfeit oxycodone pills containing fentanyl, and a quantity of cocaine, to an individual known to the Grand Jury, in exchange for a sum of United States currency.
3. On or about November 13, 2023, in the vicinity of 75 Mackey Road, Highland, New York, in Ulster County, **NICOLE KANE** provided a quantity of counterfeit oxycodone pills containing fentanyl to an individual known to the Grand Jury, in exchange for a sum of United States currency.
4. On or about November 28, 2023, in the vicinity of 56 Noxon Street, Poughkeepsie, New York, in Dutchess County, **NICOLE KANE** acquired a quantity of counterfeit oxycodone pills containing fentanyl from **DAQUAN KILLIAN**, in exchange for a sum of United States Currency, for later resale to an individual known to the Grand Jury.
5. On or about November 28, 2023, **NICOLE KANE** had a phone conversation with **ROMELL HEARN**, during which **NICOLE KANE** stated, in sum and substance, “So, hit me when you’re ready, and we’re gonna do what you usually drop me. I’m gonna throw in with him on that.”, and **ROMELL HEARN** responded, in sum and substance, “Okay, okay.”
6. On or about November 28, 2023, in the vicinity of 721 Main Street, Poughkeepsie, New York, in Dutchess County, **NICOLE KANE** acquired a quantity of cocaine from **ROMELL HEARN**, in exchange for a sum of United States Currency, for later resale to an individual known to the Grand Jury.
7. On December 6, 2023, in the vicinity of 75 Mackey Road, Highland, New York, in Ulster County, **NICOLE KANE** provided a quantity of counterfeit oxycodone pills

- containing fentanyl to an individual known to the Grand Jury, in exchange for a sum of United States currency.
8. On December 19, 2023, **NICOLE KANE** had a phone conversation with **ROMELL HEARN**, during which **ROMELL HEARN** stated, in sum and substance, “I said I’ll be right there, I’ll be there in like five minutes.”, and **NICOLE KANE** responded, in sum and substance, “Alright, I’m here.”
  9. On or about December 19, 2023, in the vicinity of 721 Main Street, Poughkeepsie, New York, in Dutchess County, **NICOLE KANE** acquired a quantity of cocaine weighing in excess of two ounces from **ROMELL HEARN**, in exchange for a sum of United States Currency, for later resale to an individual known to the Grand Jury.
  10. On or about December 21, 2023, in the vicinity of 2585 South Road, Town of Poughkeepsie, New York, in Dutchess County, **NICOLE KANE** acquired a quantity of counterfeit oxycodone pills containing fentanyl from **DAQUAN KILLIAN**, in exchange for a sum of United States Currency, for later resale to an individual known to the Grand Jury.
  11. On or about January 6, 2024, in the vicinity of 721 Main Street, Poughkeepsie, New York, in Dutchess County, **NICOLE KANE** acquired a quantity of cocaine from **ROMELL HEARN**, in exchange for a sum of United States Currency, for later resale to an individual known to the Grand Jury.
  12. On or about January 6, 2024, in the vicinity of 16 Boulevard Knolls, Poughkeepsie, New York, in Dutchess County, **ROMELL HEARN** and **DWAN SCAFE** exited Unit 3 of that location and traveled together to the vicinity of 721 Main Street,

Poughkeepsie, New York, in Dutchess County, to provide **NICOLE KANE** with an additional quantity of cocaine.

13. On or about January 29, 2024, **NICOLE KANE** and **ROMELL HEARN** had a phone conversation, during which **ROMELL HEARN** stated, in sum and substance, "...Just pull out of the parking lot...and then, then, then take a quick right, and a quick right, and just park on the street.", to which **NICOLE KANE** stated, in sum and substance, "Over, over by like Flannery by Corlies, right?", to which **ROMELL HEARN** stated, in sum and substance, "Yeah, yeah, yeah."
14. On or about January 29, 2024, in the vicinity of Flannery Street and Corlies Avenue, Poughkeepsie, New York, in Dutchess County, **NICOLE KANE** acquired a quantity of cocaine weighing in excess of two ounces from **ROMELL HEARN**, in exchange for a sum of United States Currency, for later resale to an individual known to the Grand Jury.
15. On or about February 25, 2024, in the vicinity of Flannery Street and Corlies Avenue, Poughkeepsie, New York, in Dutchess County, **NICOLE KANE** acquired a quantity of cocaine, and a quantity of counterfeit oxycodone pills containing fentanyl, from **ROMELL HEARN**, in exchange for a sum of United States Currency, for later resale to an individual known to the Grand Jury.
16. On or about March 7, 2024, **DWAN SCAFE** entered Unit 3 at 16 Boulevard Knolls, Poughkeepsie, New York, in Dutchess County, to acquire a quantity of cocaine weighing in excess of 8 ounces for later resale.
17. On or about March 7, 2024, in the vicinity of Yorktown Heights, Westchester County, New York, a quantity of cocaine weighing in excess of 8 ounces was seized from

Damian Cunningham after **DWAN SCAFE** provided it to Cunningham in Dutchess County.

18. On or about March 10, 2024, **NICOLE KANE** sent two SMS text messages to an individual known to the Grand Jury which stated, in sum and substance, “Yo, I know it’s late my fault I’m gonna give you dude’s number so you can hit him cause I slept all day today”, and “845-392-0666 (diggs)”, respectively.
19. On or about March 11, 2024, **JONTE HATCHER** had a phone conversation with an individual known to the Grand Jury, during which the individual known to the Grand Jury stated, in sum and substance, “...Let’s do the hundred on the—we’ll do a hundred at the two-seven on the soft, and then, like I said, I’ll have eight hundred play money that we could play with.”, to which **JONTE HATCHER** stated, in sum and substance, “Copy, I’ll tell you that and I’ll have that ready.”
20. On or about March 11, 2024, in the vicinity of 124 Montgomery Street, Poughkeepsie, New York, in Dutchess County, **JONTE HATCHER** sold a quantity of cocaine, and a quantity of counterfeit oxycodone pills containing fentanyl, to an individual known to the Grand Jury, in exchange for a sum of United States Currency.
21. On or about March 21, 2024, in the vicinity of 124 Montgomery Street, Poughkeepsie, New York, in Dutchess County, **JONTE HATCHER** sold a quantity of counterfeit oxycodone pills containing fentanyl to an individual known to the Grand Jury, in exchange for a sum of United States Currency.
22. On or about April 2, 2024, in the vicinity of 124 Montgomery Street, Poughkeepsie, New York, in Dutchess County, **JONTE HATCHER** sold a quantity of counterfeit

- oxycodone pills containing fentanyl to an individual known to the Grand Jury, in exchange for a sum of United States Currency.
23. On or about April 8, 2024, **JONTE HATCHER** had a phone conversation with an individual known to the Grand Jury, during which **JONTE HATCHER** stated, in sum and substance, “Nah, it’s literally gonna be just five of those. You give him fifteen. And then you bring me the rest of the bread. And grab the two.”
24. On or about April 8, 2024, in the vicinity of 2 Executive Boulevard, Yonkers, New York, in Westchester County, an individual known to the Grand Jury acquired a quantity of counterfeit oxycodone pills containing fentanyl from an unknown Hispanic male, in exchange for a sum of United States Currency, with the meeting having been arranged by **JONTE HATCHER**.
25. On or about April 8, 2024, in the vicinity of 65 South Hamilton Street, Poughkeepsie, New York, in Dutchess County, **JONTE HATCHER** sold a quantity of counterfeit oxycodone pills containing fentanyl to an individual known to the Grand Jury, in exchange for a sum of United States Currency.
26. On or about April 17, 2024, **JONTE HATCHER** sent an SMS text message to an individual known to the Grand Jury, which stated, in sum and substance, “Ok what’s count.”
27. On or about April 18, 2024, in the vicinity of 65 South Hamilton Street, Poughkeepsie, New York, in Dutchess County, **JONTE HATCHER** sold a quantity of counterfeit oxycodone pills containing fentanyl to an individual known to the Grand Jury, in exchange for a sum of United States Currency.



28. On or about May 5, 2024, **JONTE HATCHER** sent an SMS text message to an individual known to the Grand Jury, which stated, in sum and substance, “Just give me the count”.
29. On or about May 6, 2024, in the vicinity of 65 South Hamilton Street, Poughkeepsie, New York, in Dutchess County, **JONTE HATCHER** sold a quantity of counterfeit oxycodone pills containing fentanyl to an individual known to the Grand Jury, in exchange for a sum of United States Currency.
30. On or about May 23, 2024, inside of 16 Boulevard Knolls, Unit 3, Poughkeepsie, New York, in Dutchess County, **ROMELL HEARN** and **DWAN SSAFE** possessed a quantity of cocaine weighing in excess of 8 ounces.
31. On or about June 14, 2024, **JONTE HATCHER** had a phone conversation with an individual known to the Grand Jury, during which the individual known to the Grand Jury stated, in sum and substance, “Half, half of the last. Half.”, and **JONTE HATCHER** responded, in sum and substance, “Alright, copy. I got you.”
32. On or about June 14, 2024, in the vicinity of 65 South Hamilton Street, Poughkeepsie, New York, in Dutchess County, **JONTE HATCHER** sold a quantity of counterfeit oxycodone pills containing fentanyl to an individual known to the Grand Jury, in exchange for a sum of United States Currency.
33. On or about June 24, 2024, **JONTE HATCHER** had a phone conversation with an individual known to the Grand Jury, during which **JONTE HATCHER** stated, in sum and substance, “Fifteen what?”, and the individual known to the Grand Jury stated, in sum and substance, “One five. Add a couple of zeroes. Of the usual.”

34. On or about June 24, 2024, in the vicinity of 262 Hooker Avenue, Poughkeepsie, New York, in Dutchess County, **JONTE HATCHER** sold a quantity of counterfeit oxycodone pills containing fentanyl to an individual known to the Grand Jury, in exchange for a sum of United States Currency.
35. On or about June 27, 2024, in the vicinity of 96 South Hamilton Street, Poughkeepsie, New York, in Dutchess County, **JONTE HATCHER** sold a quantity of cocaine, and sold a quantity of counterfeit oxycodone pills containing fentanyl, to an individual known to the Grand Jury, in exchange for a sum of United States Currency.
36. On or about July 1, 2024, **JONTE HATCHER** had a phone conversation with an individual known to the Grand Jury, during which the individual known to the Grand Jury stated, in sum and substance, "...I was going to grab another five-zero.", and **JONTE HATCHER** stated, in sum and substance, "When, today? Come on."
37. On or about July 1, 2024, in the vicinity of 1401 Route 300, Newburgh, New York, in Orange County, **JONTE HATCHER** sold a quantity of cocaine to an individual known to the Grand Jury, in exchange for a sum of United States Currency.
38. On or about July 11, 2024, **JONTE HATCHER** had a phone conversation with an individual known to the Grand Jury, during which the individual known to the Grand Jury stated, in sum and substance, "I need fifteen. You heard?", and **JONTE HATCHER** stated, in sum and substance, "Blues?"
39. On or about July 11, 2024, in the vicinity of 1401 Route 300, Newburgh, New York, in Orange County, **JONTE HATCHER** sold a quantity of counterfeit oxycodone pills containing fentanyl to an individual known to the Grand Jury, in exchange for a sum of United States Currency.

40. On or about August 7, 2024, **JONTE HATCHER** had a phone conversation with an individual known to the Grand Jury, during which **JONTE HATCHER** stated, in sum and substance, “What I’ll do is I’ll meet you in Newburgh.”
41. On or about August 7, 2024, in the vicinity of 1401 Route 300, Newburgh, New York, in Orange County, **JONTE HATCHER** sold a quantity of cocaine to an individual known to the Grand Jury, in exchange for a sum of United States Currency.
42. On or about August 8, 2024, **JONTE HATCHER** had a phone conversation with an individual known to the Grand Jury, during which **JONTE HATCHER** stated, in sum and substance, “No it would be, it would be the same ticket. Twenty-seven.”
43. On or about August 8, 2024, in the vicinity of 1278 Route 300, Newburgh, New York, in Orange County, **JONTE HATCHER** sold a quantity of cocaine, and a quantity of counterfeit oxycodone pills containing fentanyl, to an individual known to the Grand Jury, in exchange for a sum of United States Currency.
44. On or about August 14, 2024, **JONTE HATCHER** had a phone conversation with an individual known to the Grand Jury, during which the individual known to the Grand Jury stated, in sum and substance, “Let me get three. Half and half.”, and **JONTE HATCHER** stated, in sum and substance, “Okay, copy. Understood.”
45. On or about August 15, 2024, in the vicinity of 1401 Route 300, Newburgh, New York, in Orange County, **JONTE HATCHER** sold a quantity of cocaine to an individual known to the Grand Jury, in exchange for a sum of United States Currency.
46. On or about August 29, 2024, in the vicinity of Creek Road and New Hamburg Road, Wappinger, New York, in Dutchess County, **JONTE HATCHER** and **SHAMIQUE DELAINE** possessed a quantity of cocaine inside of a white BMW SUV.

47. On or about August 29, 2024, inside of 57 Carroll Street, Apt. 104, Poughkeepsie, New York, in Dutchess County, **JONTE HATCHER** and **SHAMIQUE DELAINE** possessed a quantity of cocaine and a quantity of fentanyl.

**COUNT 3**

THE GRAND JURY OF DUTCHESS COUNTY, by this Indictment, accuses the defendant, **NICOLE KANE**, of the crime of **CRIMINAL SALE OF A CONTROLLED SUBSTANCE IN THE THIRD DEGREE**, in violation of Section 220.39(1) of the Penal Law of the State of New York, committed as follows:

Said defendant, on or about October 24, 2023, in Ulster County, did knowingly and unlawfully sell a narcotic drug.

**COUNT 4**

THE GRAND JURY OF DUTCHESS COUNTY, by this Indictment, accuses the defendant, **NICOLE KANE**, of the crime of **CRIMINAL POSSESSION OF A CONTROLLED SUBSTANCE IN THE THIRD DEGREE**, in violation of Section 220.16(1) of the Penal Law of the State of New York, committed as follows:

Said defendant, on or about October 24, 2023, in Ulster County, did knowingly and unlawfully possess a narcotic drug with intent to sell it.

**COUNT 5**

Said defendant, on or about October 26, 2023, in Ulster County, did knowingly and unlawfully sell a narcotic drug.

**COUNT 6**

THE GRAND JURY OF DUTCHESS COUNTY, by this Indictment, accuses the defendant, **NICOLE KANE**, of the crime of **CRIMINAL SALE OF A CONTROLLED SUBSTANCE IN THE THIRD DEGREE**, in violation of Section 220.39(1) of the Penal Law of the State of New York, committed as follows:

Said defendant, on or about October 26, 2023, in Ulster County, did knowingly and unlawfully sell a narcotic drug; to wit: cocaine.

**COUNT 7**

THE GRAND JURY OF DUTCHESS COUNTY, by this Indictment, accuses the defendant, **NICOLE KANE**, of the crime of **CRIMINAL POSSESSION OF A CONTROLLED SUBSTANCE IN THE THIRD DEGREE**, in violation of Section 220.16(1) of the Penal Law of the State of New York, committed as follows:

Said defendant, on or about October 26, 2023, in Ulster County, did knowingly and unlawfully possess a narcotic drug with intent to sell it.

THE GRAND JURY OF DUTCHESS COUNTY, by this Indictment, accuses the defendant, **NICOLE KANE**, of the crime of **CRIMINAL POSSESSION OF A CONTROLLED SUBSTANCE IN THE THIRD DEGREE**, in violation of Section 220.16(1) of the Penal Law of the State of New York, committed as follows:

Said defendant, on or about November 13, 2023, in Ulster County, did knowingly and unlawfully possess a narcotic drug with intent to sell it.

**COUNT 10**

THE GRAND JURY OF DUTCHESS COUNTY, by this Indictment, accuses the defendants, **NICOLE KANE** and **DAQUAN KILLIAN**, of the crime of **CRIMINAL SALE OF A CONTROLLED SUBSTANCE IN THE THIRD DEGREE**, in violation of Section 220.39(1) of the Penal Law of the State of New York, committed as follows:

Said defendants, acting in concert with each other, on or about November 28, 2023, in Dutchess County and Ulster County, did knowingly and unlawfully sell a narcotic drug.

**COUNT 11**

THE GRAND JURY OF DUTCHESS COUNTY, by this Indictment, accuses the defendants, **NICOLE KANE** and **ROMELL HEARN**, of the crime of **CRIMINAL SALE OF A CONTROLLED SUBSTANCE IN THE SECOND DEGREE**, in violation of Section 220.41(1) of the Penal Law of the State of New York, committed as follows:

Said defendants, acting in concert with each other, on or about November 28, 2023, in Dutchess County and Ulster County, did knowingly and unlawfully sell one or more preparations, compounds, mixtures or substances containing a narcotic drug; to wit: cocaine; and said preparations, compounds, mixtures or substances were of an aggregate weight of one-half ounce or more.

**COUNT 13**

THE GRAND JURY OF DUTCHESS COUNTY, by this Indictment, accuses the defendants, **NICOLE KANE** and **ROMELL HEARN**, of the crime of **CRIMINAL SALE OF A CONTROLLED SUBSTANCE IN THE THIRD DEGREE**, in violation of Section 220.39(1) of the Penal Law of the State of New York, committed as follows:

Said defendants, acting in concert with each other, on or about November 28, 2023, in Dutchess County and Ulster County, did knowingly and unlawfully sell a narcotic drug; to wit: cocaine.

**COUNT 14**

THE GRAND JURY OF DUTCHESS COUNTY, by this Indictment, accuses the defendants, **NICOLE KANE** and **ROMELL HEARN**, of the crime of **CRIMINAL POSSESSION OF A CONTROLLED SUBSTANCE IN THE THIRD DEGREE**, in violation of Section 220.16(1) of the Penal Law of the State of New York, committed as follows:

Said defendants, acting in concert with each other, on or about November 28, 2023, in Dutchess County and Ulster County, did knowingly and unlawfully possess a narcotic drug; to wit: cocaine; with intent to sell it.

**COUNT 15**

THE GRAND JURY OF DUTCHESS COUNTY, by this Indictment, accuses the defendants, **NICOLE KANE** and **ROMELL HEARN**, of the crime of **CRIMINAL POSSESSION OF A CONTROLLED SUBSTANCE IN THE THIRD DEGREE**, in violation of Section 220.16(12) of the Penal Law of the State of New York, committed as follows:

Said defendants, acting in concert with each other, on or about November 28, 2023, in Dutchess County and Ulster County, did knowingly and unlawfully possess one or more preparations, compounds, mixtures or substances containing a narcotic drug; to wit: cocaine; and said preparations, compounds, mixtures or substances were of an aggregate weight of one-half ounce or more.

**COUNT 16**
