THE GRAND JURY OF THE COUNTY OF THE BRONX BY THIS INDICTMENT, ACCUSES THE DEFENDANT ERIK DURAN OF THE CRIME OF MANSLAUGHTER IN THE SECOND DEGREE COMMITTED AS FOLLOWS:

THE DEFENDANT, ERIK DURAN, ON OR ABOUT AUGUST 23, 2023, IN THE COUNTY OF THE BRONX, DID RECKLESSLY CAUSE THE DEATH OF ERIC DUPREY BY STRIKING HIM WITH A BLUNT OBJECT.

SECOND COUNT

THE GRAND JURY OF THE COUNTY OF THE BRONX BY THIS INDICTMENT, ACCUSES THE DEFENDANT ERIK DURAN OF THE CRIME OF CRIMINALLY NEGLIGENT HOMICIDE COMMITTED AS FOLLOWS:

THE DEFENDANT, ERIK DURAN, ON OR ABOUT AUGUST 23, 2023, IN THE COUNTY OF THE BRONX, WITH CRIMINAL NEGLIGENCE, DID CAUSE THE DEATH OF ERIC DUPREY BY STRKING HIM WITH A BLUNT OBJECT.

THIRD COUNT

THE GRAND JURY OF THE COUNTY OF THE BRONX BY THIS INDICTMENT, ACCUSES THE DEFENDANT ERIK DURAN OF THE CRIME OF ASSAULT IN THE FIRST DEGREE COMMITTED AS FOLLOWS:

THE DEFENDANT, ERIK DURAN, ON OR ABOUT AUGUST 23, 2023, IN THE COUNTY OF THE BRONX, WITH INTENT TO CAUSE SERIOUS PHYSICAL INJURY TO ERIC DUPREY, DID CAUSE SERIOUS PHYSICAL INJURY TO ERIC DUPREY, BY MEANS OF A DANGEROUS INSTRUMENT, THAT BEING A BLUNT OBJECT.

FOURTH COUNT

THE GRAND JURY OF THE COUNTY OF THE BRONX BY THIS INDICTMENT, ACCUSES THE DEFENDANT ERIK DURAN OF THE CRIME OF ASSAULT IN THE SECOND DEGREE COMMITTED AS FOLLOWS:
