Defendant MARK SALKEY, from on or about and between October 10, 2023 and November 16, 2023, in the County of KINGS, knowing that a written instrument contained a false statement or false information and with intent to defraud the state or any political subdivision, public authority or public benefit corporation of the state, he offered or presented it to a public office, public servant, public authority or public benefit corporation with the knowledge or belief that it would be filed with, registered or recorded in or otherwise become a part of the records of such public office, public servant, public authority or public benefit corporation, to wit: a deed.

COUNT TWENTY-THREE

THE GRAND JURY OF THE COUNTY OF KINGS, by this Indictment, accuses THE DEFENDANT MARK SALKEY of committing the crime of **FALSIFYING BUSINESS RECORDS IN THE FIRST DEGREE**, in violation of Penal Law §175.10, committed as follows:
