COUNT ONE

THE GRAND JURY OF THE COUNTY OF ALBANY, by this Indictment, accuses the defendant, JASPER MILLS, of the crime of TAMPERING WITH A WITNESS IN THE FIRST DEGREE in violation of §215.13(1) of the Penal Law of the State of New York, committed as follows:

Said defendant, on or about and in between June 3, 2024 and September 8, 2024, in the County of Albany, State of New York and elsewhere in the State of New York, while acting in concert with others, intentionally caused serious physical injury to a person known to this Grand Jury for the purpose of obstructing, delaying, preventing, or impeding the giving of testimony in a criminal proceeding by such person or another person or for the purpose of compelling such person or another person to swear falsely.

COUNT TWO

AND THE AFORESAID GRAND JURY, by this Indictment, accuses the defendant, JASPER MILLS, of the crime of TAMPERING WITH A WITNESS IN THE SECOND DEGREE in violation of §215.12(1) of the Penal Law of the State of New York, committed as follows:

Said defendant, on or about and in between June 3, 2024 and September 8, 2024, in the County of Albany, State of New York and elsewhere in the State of New York, while acting in concert with others, intentionally caused physical injury to a person known to this Grand Jury for the purpose of obstructing, delaying, preventing, or impeding the giving of testimony in a criminal proceeding by such person or another person or for the purpose of compelling such person or another person to swear falsely.

COUNT THREE

AND THE AFORESAID GRAND JURY, by this Indictment, accuses the defendant, JASPER MILLS, of the crime of INTIMIDATING A WITNESS IN THE FIRST DEGREE in violation of §215.17(1) of the Penal Law of the State of New York, committed as follows:

Said defendant, on or about and in between June 3, 2024 and September 8, 2024, in the County of Albany, State of New York and elsewhere in the State of New York, while acting in concert with others, intentionally caused serious physical injury to a person known to this Grand Jury for the purpose of obstructing, delaying, preventing, or impeding the communication by such person or another person of information relating to a criminal transaction to any court, grand jury, prosecutor, police officer, or peace officer or for the person of compelling such person or another person to swear falsely, while not in the course of that criminal transaction or immediate flight therefrom.

COUNT FOUR

AND THE AFORESAID GRAND JURY, by this Indictment, accuses the defendant, JASPER MILLS, of the crime of INTIMIDATING A WITNESS IN THE SECOND DEGREE in violation of §215.16(1) of the Penal Law of the State of New York, committed as follows:

Said defendant, on or about and in between June 3, 2024 and September 8, 2024, in the County of Albany, State of New York and elsewhere in the State of New York, while acting in concert with others, intentionally caused physical injury to a person known to this Grand Jury for the purpose of obstructing, delaying, preventing, or impeding the communication by such person or another person of information relating to a criminal transaction to any court, grand jury, prosecutor, police officer, or peace officer or for the person of compelling such person or another

person to swear falsely, while not in the course of that criminal transaction or immediate flight therefrom.

COUNT FIVE

AND THE AFORESAID GRAND JURY, by this Indictment, accuses the defendant, JASPER MILLS, of the crime of CRIMINAL CONTEMPT IN THE SECOND DEGREE in violation of §215.50(3) of the Penal Law of the State of New York, committed as follows:

Said defendant, on or about April 8, 2024 in the County of Albany, State of New York, intentionally disobeyed or resisted the lawful process or other mandate of a court that did not involve or grow out of a labor dispute as defined in subdivision two of section seven hundred fifty-three-a of the judiciary law, to wit a protective order dated October 27, 2022 issued by the Honorable Judge Roger D. McDonough in Albany County Supreme Court under Albany County indictment number 71634-2022 and index number 378-2022.

COUNT SIX

AND THE AFORESAID GRAND JURY, by this Indictment, accuses the defendant, JASPER MILLS, of the crime of CRIMINAL CONTEMPT IN THE SECOND DEGREE in violation of §215.50(3) of the Penal Law of the State of New York, committed as follows:


Said defendant, on or about and between June 3, 2024 and June 5, 2024 in the County of Albany, State of New York, intentionally disobeyed or resisted the lawful process or other mandate of a court that did not involve or grow out of a labor dispute as defined in subdivision two of section seven hundred fifty-three-a of the judiciary law, to wit a protective order dated October 27, 2022 issued by the Honorable Judge Roger D. McDonough in Albany County Supreme Court under Albany County indictment number 71634-2022 and index number 378-2022.

COUNT SEVEN

AND THE AFORESAID GRAND JURY, by this Indictment, accuses the defendant, JASPER MILLS, of the crime of CRIMINAL CONTEMPT IN THE SECOND DEGREE in violation of §215.50(3) of the Penal Law of the State of New York, committed as follows:

Said defendant, on or about and in between June 3, 2024 and June 5, 2024 in the County of Albany, State of New York, intentionally disobeyed or resisted the lawful process or other mandate of a court that did not involve or grow out of a labor dispute as defined in subdivision two of section seven hundred fifty-three-a of the judiciary law, to wit a protective order dated October 27, 2022 issued by the Honorable Judge Roger D. McDonough in Albany County Supreme Court under Albany County indictment number 71634-2022 and index number 378-2022, and this being a separate and distinct action then from the actions charged in Count Six of this Indictment.
