THE GRAND JURY OF THE COUNTY OF ORANGE, by this Indictment, accuses the defendant of the crime of VEHICULAR MANSLAUGHTER IN THE SECOND DEGREE, in violation of the provisions of Section 125.12, Subdivision 1, of the Penal Law of the State of New York, committed as follows:

The said defendant, on or about the 27<sup>th</sup> day of July, 2023, in the County of Orange, State of New York, operated a motor vehicle while he had .08 of one per centum or more by weight of alcohol in his blood as determined by a chemical analysis of his blood and/or while he was in an intoxicated condition and, as a result of such intoxication, operated a motor vehicle in a manner that caused the death of Nidia Nieves.

SECOND COUNT


AND THE GRAND JURY AFORESAID, by this Indictment, further accuses the defendant of the crime of DRIVING WHILE INTOXICATED, in violation of the provisions of Section 1192, Subdivision 2, of the Vehicle and Traffic Law of the State of New York, committed as follows:

The said defendant, on or about the 27<sup>th</sup> day of July, 2023, in the County of Orange, State of New York, operated a motor vehicle while having .08 of one per centum or more by weight of alcohol in his blood, as shown by chemical analysis of his blood.

THIRD COUNT

AND THE GRAND JURY AFORESAID, by this Indictment, further accuses the defendant of the crime of DRIVING WHILE INTOXICATED, in violation of the provisions of Section 1192, Subdivision 3, of the Vehicle and Traffic Law of the State of New York, committed as follows:

The said defendant, on or about the 27<sup>th</sup> day of July, 2023, in the County of Orange, State of New York, operated a motor vehicle while in an intoxicated condition.
