**COUNT 1**

THE GRAND JURY OF KINGS COUNTY, by this Indictment, accuses the defendant, **KHYLE WILLIAMS** of the crime of **CONSPIRACY IN THE FOURTH DEGREE**, in violation of § 105.10(1) of the Penal Law of the State of New York, committed as follows:

On or about and between May 30, 2025 and October 15, 2025 in Kings County and elsewhere inside and outside the State of New York, with intent that conduct constituting the crime of Criminal Sale of a Firearm in the First Degree, in violation of Section 265.13(2), said crime being a class B felony, be committed, the defendant did knowingly and intentionally agree with others, known and unknown, to engage in and cause the performance of such conduct as would constitute the above-mentioned class B felony.

**PREAMBLE**

It was the purpose of this conspiracy to obtain, possess, control, transport and sell firearms in Kings County and elsewhere inside and outside the State of New York, and to collect the proceeds from the sale of those firearms.

It was the role of **KHYLE WILLIAMS** to obtain, transfer, possess, control and sell firearms and accessories to others in Kings County and elsewhere inside and outside the State of New York.

It was part of this conspiracy for members of the conspiracy to communicate with each other and others over cellular telephones using codes and communicating in a guarded, cryptic manner.

### **OVERT ACTS**

In furtherance of said conspiracy and to achieve the objects thereof, and during the course thereof, the following overt acts, among others, were committed:

1. On or about May 30, 2025, **KHYLE WILLIAMS** messaged, via Telegram, an individual known to the Grand Jury to let said individual know he was coming outside.
2. On or about May 30, 2025, in Kings County, **KHYLE WILLIAMS** met an individual known to the Grand Jury and introduced himself as “Rico.”
3. On or about May 30, 2025, in Kings County, **KHYLE WILLIAMS**, entered a residential building, to obtain firearms.
4. On or about May 30, 2025, in Kings County, **KHYLE WILLIAMS**, entered a vehicle with an individual known to the Grand Jury and handed said individual a bag containing four loaded 9-millimeter pistols and ammunition in exchange for a sum of United States Currency.
5. On or about May 30, 2025, in Kings County, **KHYLE WILLIAMS**, in the presence of an individual known to the Grand Jury, engaged in a telephone conversation with an unknown individual and informed the unknown individual that “we are missing a clip.”

6. On or about May 30, 2025, in Kings County, **KHYLE WILLIAMS**, re-entered a vehicle with an individual known to the Grand Jury and handed said individual a 9-millimeter magazine.
7. On or about June 2, 2025, **KHYLE WILLIAMS** messaged, via Telegram, an individual known to the Grand Jury to let said individual know he was “grabbing it” and coming down.
8. On or about June 2, 2025, in Kings County, **KHYLE WILLIAMS**, entered a residential building, to obtain firearms.
9. On or about June 2, 2025, in Kings County, **KHYLE WILLIAMS**, entered a vehicle with an individual known to the Grand Jury and handed said individual a bag containing two firearms - one Rossi .38 caliber revolver and one .380 caliber pistol, in exchange for a sum of United States Currency.
10. On or about June 2, 2025, in Kings County, **KHYLE WILLIAMS**, discussed with an individual known to the Grand Jury, procuring switches for said individual.
11. On or about June 26, 2025, **KHYLE WILLIAMS** messaged, via Telegram, an individual known to the Grand Jury, a photo of firearms for sale.
12. On or about June 26, 2025, **KHYLE WILLIAMS** called, via Telegram, an individual known to the Grand Jury, and discussed prices for a possible firearm sale.
13. On or about June 29, 2025, **KHYLE WILLIAMS** called, via Telegram, an individual known to the Grand Jury, and discussed arrangements to meet the following day for a firearm sale.
14. On or about June 30, 2025, in Kings County, **KHYLE WILLIAMS**, entered a vehicle with an individual known to the Grand Jury and handed said individual a bag containing

three loaded 9-millimeter pistols and ammunition in exchange for a sum of United States Currency.

15. On or about June 30, 2025, in Kings County, **KHYLE WILLIAMS**, in the presence of an individual known to the Grand Jury, engaged in a telephone conversation with an unknown individual and informed the unknown individual that “we are missing food.”
16. On or about June 30, 2025, in Kings County, **KHYLE WILLIAMS**, entered a residential building to obtain ammunition.
17. On or about June 30, 2025, in Kings County, **KHYLE WILLIAMS**, re-entered a vehicle with an individual known to the Grand Jury and handed said individual a bag containing ammunition.
18. On or about July 13, 2025, **KHYLE WILLIAMS** messaged, via Telegram, an individual known to the Grand Jury, a photo of firearms for sale.
19. On or about July 13, 2025, **KHYLE WILLIAMS** called, via Telegram, an individual known to the Grand Jury, and discussed pricing for a possible firearm sale.
20. On or about July 13, 2025, **KHYLE WILLIAMS** called, via Telegram, an individual known to the Grand Jury, and discussed arrangements to meet the following day for a firearm sale.
21. On or about July 14, 2025, in Kings County, **KHYLE WILLIAMS**, operated a CitiBike to a residential building on Clarkson Avenue.
22. On or about July 14, 2025, in Kings County, **KHYLE WILLIAMS**, entered a residential building, to obtain firearms.

23. On or about July 14, 2025, in Kings County, **KHYLE WILLIAMS**, entered a vehicle with an individual known to the Grand Jury and handed said individual a bag containing one loaded SCCY 9-millimeter pistol in exchange for a sum of United States Currency.
24. On or about July 17, 2025, **KHYLE WILLIAMS** called, via Telegram, an individual known to the Grand Jury, and discussed pricing and arrangements for a possible firearm sale.
25. On or about July 18, 2025, **KHYLE WILLIAMS** messaged, via Telegram, an individual known to the Grand Jury, a photo of a magazine.
26. On or about July 18, 2025, in Kings County, **KHYLE WILLIAMS**, entered a vehicle with an individual known to the Grand Jury, carrying a box containing four firearms and ammunition.
27. On or about July 18, 2025, in Kings County, **KHYLE WILLIAMS**, sold to an individual known to the Grand Jury three loaded 9-millimeter pistols and one loaded .40 caliber pistol in exchange for a sum of United States Currency.
28. On or about July 28, 2025, **KHYLE WILLIAMS** messaged, via Telegram, an individual known to the Grand Jury, a photo of firearms for sale.
29. On or about July 28, 2025, **KHYLE WILLIAMS** discussed on a phone call, via Telegram, with an individual known to the Grand Jury, pricing for two firearms.
30. On or about July 29, 2025, **KHYLE WILLIAMS**, during a series of coded, guarded and cryptic communications, discussed with an individual known to the Grand Jury, pricing for the sale of firearms.

31. On or about July 29, 2025, **KHYLE WILLIAMS** over a phone call, via Telegram, instructed an individual known to the Grand Jury to come meet **WILLIAMS** to purchase six firearms.
32. On or about July 29, 2025, in Kings County, **KHYLE WILLIAMS**, entered a vehicle with an individual known to the Grand Jury, and handed a bag containing six firearms - two loaded .380 caliber pistols, two .38 caliber revolvers, one 9-millimeter pistol and one .32 caliber pistol - and ammunition to an individual known to the Grand Jury in exchange for a sum of United States Currency.
33. On or about July 29, 2025, in Kings County, **KHYLE WILLIAMS**, entered a residential location to obtain ammunition.
34. On or about August 7, 2025, in Kings County, **KHYLE WILLIAMS**, entered a vehicle with an individual known to the Grand Jury, and handed a bag containing four firearms - three loaded 9-millimeter pistols and one loaded .38 caliber revolver – and ammunition in exchange for a sum of United States Currency.
35. On or about August 7, 2025, in Kings County, **KHYLE WILLIAMS**, in the presence of an individual known to the Grand Jury, had a telephone conversation with an unknown individual and asked the unknown individual how to de-cock one of the firearms.
36. On or about August 21, 2025, **KHYLE WILLIAMS** discussed on a phone call, via Telegram, with an individual known to the Grand Jury, the possible sale of two firearms.
37. On or about August 21, 2025, **KHYLE WILLIAMS** discussed on a phone call, via Telegram, with an individual known to the Grand Jury, the prices of three firearms that **WILLIAMS** had for sale.

38. On or about August 22, 2025, in Kings County, **KHYLE WILLIAMS**, entered a vehicle with an individual known to the Grand Jury, and handed a bag containing five firearms - two loaded 9-millimeter pistols, one loaded .380 caliber pistol, one loaded .38 caliber revolver and one loaded .45 caliber pistol - and ammunition in exchange for a sum of United States Currency.
39. On or about October 3, 2025, **KHYLE WILLIAMS** messaged, via Telegram, an individual known to the Grand Jury, a photo of two firearms and asked said individual to call him.
40. On or about October 4, 2025, **KHYLE WILLIAMS** called, via Telegram, an individual known to the Grand Jury, and informed said individual that **WILLIAMS** would have two firearms for said individual.
41. On or about October 12, 2025, **KHYLE WILLIAMS** messaged, via Telegram, an individual known to the Grand Jury, a photo of three firearms for sale.
42. On or about October 12, 2025, **KHYLE WILLIAMS** called, via Telegram, an individual known to the Grand Jury, and told said individual that **WILLIAMS** would have four firearms for said individual.
43. On or about October 15, 2025, in Kings County, **KHYLE WILLIAMS**, entered a vehicle with an individual known to the Grand Jury, and handed a bag containing three firearms - one loaded 9-millimeter Taurus pistol, one loaded Cobra .380 caliber pistol and one loaded North American Arms .22 caliber revolver – and ammunition in exchange for a sum of United States Currency.

**COUNT 2**

THE GRAND JURY OF KINGS COUNTY, by this Indictment, accuses the defendant, **KHYLE WILLIAMS** of the crime of **CRIMINAL SALE OF A FIREARM IN THE FIRST DEGREE** in violation of §265.13(2) of the Penal Law of the State of New York, committed as follows:

Said defendant, on or about May 30, 2025, in the County of Kings, State of New York, did unlawfully sell, exchange, give or dispose of to another person or persons a total of three or more firearms in a period of not more than one year, to wit: four 9-millimeter pistols (Serial Nos. JKZ9251, 23CB10110, 451-85396 and ACE959237).

**COUNT 3**

THE GRAND JURY OF KINGS COUNTY, by this Indictment, accuses the defendant, **KHYLE WILLIAMS** of the crime of **CRIMINAL SALE OF A FIREARM IN THE SECOND DEGREE** in violation of §265.12(2) of the Penal Law of the State of New York, committed as follows:

Said defendant, on or about May 30, 2025, in the County of Kings, State of New York, did unlawfully sell, exchange, give or dispose of to another person or persons a total of two or more firearms in a period of not more than one year, to wit: four 9-millimeter pistols (Serial Nos. JKZ9251, 23CB10110, 451-85396 and ACE959237).

**COUNT 4**

THE GRAND JURY OF KINGS COUNTY, by this Indictment, accuses the defendant, **KHYLE WILLIAMS** of the crime of **CRIMINAL POSSESSION OF A WEAPON IN THE**

**THIRD DEGREE** in violation of §265.02(5)(i) of the Penal Law of the State of New York, committed as follows:

Said defendant, on or about May 30, 2025, in the County of Kings, State of New York, did possess three or more firearms, to wit: four 9-millimeter pistols (Serial Nos. JKZ9251, 23CB10110, 451-85396 and ACE959237).

**COUNT 5**

THE GRAND JURY OF KINGS COUNTY, by this Indictment, accuses the defendant, **KHYLE WILLIAMS** of the crime of **CRIMINAL SALE OF A FIREARM IN THE THIRD DEGREE** in violation of §265.11(1) of the Penal Law of the State of New York, committed as follows:

Said defendant, on or about May 30, 2025, in the County of Kings, State of New York, while not authorized pursuant to law to possess a firearm, did unlawfully sell, exchange, give or dispose of to another person a firearm, to wit: one 9-millimeter pistol (Serial No. JKZ9251).
