THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendant, RICKY PAULINO, acting in concert with another or others, of committing the crime of CRIMINAL POSSESSION OF STOLEN PROPERTY IN THE SECOND DEGREE, in violation of § 165.52 of the Penal Law of the State of New York, committed as follows:

Said defendant, on or about January 28, 2023, in Bronx County, and elsewhere inside of the State of New York, acting in concert with others, knowingly possessed stolen property, with intent to benefit themselves or a person other than the owner thereof, or to impede the recovery by the owner thereof, and the value of the property exceeded fifty thousand dollars, to wit: a 2022 Honda CRV, VIN 7FARW2H55NE040878, and a 2020 light-blue Honda CRV, VIN 2HKRW2H50LH627533.

COUNT 2

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendant, RICKY PAULINO, acting in concert with another or others, of committing the crime of CRIMINAL POSSESSION OF STOLEN PROPERTY IN THE THIRD DEGREE, in violation of § 165.50 of the Penal Law of the State of New York, committed as follows:

COUNT 11

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendants, RICKY PAULINO and RAHINIER PAULINO, each aiding and acting in concert with each other and others both known and unknown to the grand jury, of the crime of **CONSPIRACY IN THE FIFTH DEGREE**, in violation of § 105.05(1) of the Penal Law of the State of New York, committed as follows:

From on or about and between April 13, 2023 and April 20, 2023, in Bronx County, and elsewhere in the State of New York, with intent that conduct constituting a felony be performed, that felony being the crime of CRIMINAL POSSESSION OF STOLEN PROPERTY IN THE THIRD DEGREE, a Class D felony, in violation of § 165.50 of the Penal Law of the State of New York, the defendants did knowingly and intentionally agree with one or more persons to engage in or cause the performance of such conduct.

PREAMBLE

It was the purpose of this conspiracy to steal, transport, possess vehicles, valued in excess of three thousand dollars, with intent to benefit themselves or persons other than the owner thereof, from locations in Bronx County, and elsewhere in the State of New York, and to collect the proceeds from those stolen property transactions.

It was part of this conspiracy for RICKY PAULINO and RAHINIER PAULINO, to steal, transport, and possess stolen vehicles, valued in excess of three thousand dollars, in locations in Bronx County and elsewhere in the State of New York.

OVERT ACTS

In furtherance of the conspiracy and to affect the objects thereof, from on or about and between April 13, 2023 and April 20, 2023, the following overt acts, among others, were committed:

- 1. On or about April 18, 2023, RICKY PAULINO and RAHINIER PAULINO, acting in concert, possessed stolen property, to wit: a 2021 Honda CRV, VIN 5J6RW2H56MA006218.
- 2. On or about April 18, 2023, RICKY PAULINO and RAHINIER PAULINO, acting in concert, possessed a parking claim ticket for a parking garage located in the Bronx.

COUNT 12

THE GRAND JURY OF BRONX COUNTY, by this indictment, accuses the defendants, RICKY PAULINO and RAHINIER PAULINO, acting in concert with each other and others, of committing the crime of CRIMINAL POSSESSION OF STOLEN PROPERTY IN THE THIRD DEGREE, in violation of § 165.50 of the Penal Law of the State of New York, committed as follows:
