The Attorney General having commenced this proceeding by filing an Order to Show Cause and Verified Petition of Assistant Attorney General Jill F. Faber, dated March 26, 2018 and the supporting Affirmation of David Mossberg, Esq., Associate Attorney, Department of State, dated March 23, 2018 and upon the motion of Eric T. Schneiderman, Attorney General of the State of New York, attorney for the petitioner, the People of the State of New York,

NOW, upon reading the Order to Show Cause dated March 26, 2018, the Verified Petition, sworn to on March 26, 2018, and the supporting affirmation of David Mossberg, Esq., Associate Attorney, Department of State, dated March 23, 2018, with proof of service on respondents on March 27, 2018, and Respondents Abbingdon Hill Pet Cemetery and Crematory, Inc. and Ray Fodera having failed to answer or oppose the petition, it is

ORDERED, ADJUDGED AND DECREED that respondents are hereby permanently enjoined from violating Executive Law § 63(12), General Business Law ("GBL") Articles 22-A and GBL § 750-b and from engaging in the fraudulent, deceptive and illegal practices alleged in the Verified Petition herein, including, but not limited to operating the Abbingdon Hill Pet Cemetery and Crematory, Inc., an unlicensed pet cemetery located at 148 Youngblood Road, Montgomery, New York and/or engaging in, contracting for, or accepting payment for pet burial, cremation, care or maintenance.

ORDERED, ADJUDGED AND DECREED that respondents shall make full monetary restitution and pay damages to all aggrieved consumers, known and unknown.


ORDERED, ADJUDGED AND DECREED that respondents shall produce to the Attorney General all financial, burial and cremation records of Abbingdon Hill Pet Cemetery and Crematory, Inc., including but not limited to consumer contracts, invoices, burial plot maps or grave location records and records of cremations performed on site.

ORDERED, ADJUDGED AND DECREED that the Certificate of Incorporation of the Abbingdon Hill Pet Cemetery and Crematory, Inc., having been filed with the New York Department of State in 1995, is annulled and its corporate existence is terminated.

ORDERED, ADJUDGED AND DECREED the property and assets of the Abbingdon Hill Pet Cemetery and Crematory, Inc., shall be transferred to a suitable transferee charitable corporation, i.e. to a corporation exempt from taxation pursuant to Internal Revenue Code § 501(c)(3) and engaged in activities substantially similar to those of the Abbingdon Hill Pet Cemetery and Crematory, Inc. upon application of such charitable corporation and approval by the Attorney General of the State of New York.

ORDERED, ADJUDGED AND DECREED this court shall retain jurisdiction of the matter for all purposes, including disposition of any assets of the respondents not identified here,
