#### **COUNT ONE**

THE GRAND JURY OF ST. LAWRENCE COUNTY, by this indictment, accuses the defendants, SARAH ASHLEY, ROBERT BAKER, RASUE BARNETT, OLIVIA BENDER, AMY BENNETT, NATHANIEL BIELSKI, JAMIE BONANNO, GARY BROWN, FRANCIS BURDICK, BRANDON BYLOW, RAUL BYRD, BARRY CRAYFORD, SONIA CRUZ, LISA DAVIS, DEREK DENNY, KAYLA FLETCHER, JAMIE GAINES, JORDAN GAINES, PORSHA HOUSTON, GREGORY JAMES, DONALD JENNINGS, JENNIFER KERR, ROBERT KERWIN, RICHARD LAPLANT, JENNIFER LARUE, KIMBERLY LARUE, COREY LEE, KEVIN LOCKENWITZ, GARY LEE LOFFLER, TRAVAIL MADISON, JOSE MARCANO, JONATHAN MARTINEZ, RONDELLE MOORE, JENELLE PARKER, MARIANO PATTERSON, SHANE PERKINS, ALYSSIA PETRIE, TIFFANY RICHWAY, JENNIFER ROSENBARKER, LEE SATTLER, JOSHUA SEIDEL, RICHARD SIDES, DARREN ST. From on or before March 4, 2016, through on or about February 17, 2017, in St. Lawrence County, Jefferson County, Onondaga County, Bronx County, Monroe County, and elsewhere in the State of New York, with intent that conduct constituting the crimes of Criminal Possession of a Controlled Substance in the First Degree, Criminal Sale of a Controlled Substance in the First Degree and/or Criminal Sale of a Controlled Substance in the Second Degree, said crimes being Class A felonies, be committed, the defendants knowingly and intentionally agreed with each other and with others, known and unknown, to engage in and cause the performance of such conduct.

#### **PREAMBLE**

It was part of this conspiracy to possess and sell narcotics in St. Lawrence County, Jefferson County, Onondaga County, Bronx County, Monroe County, and elsewhere in the State of New York.

It was also part of this conspiracy for GARY LEE LOFFLER to sell narcotics to JENNIFER LARUE, FRANCIS BURDICK and SARAH ASHLEY and others.

It was also part of this conspiracy for JENNIFER LARUE, RASUE BARNETT, BARRY CRAYFORD, JOSHUA SEIDEL, MARK WILLARD, MARIANO PATTERSON, DARREN ST. GERMAIN, SEAN YOUNG, JENNIFER KERR, and SARAH AHSLEY to sell narcotics to GARY LEE LOFFLER and others.

It was also part of this conspiracy for OLIVIA BENDER, BRANDON BYLOW, COREY LEE, JAMIE BONANNO, AMY BENNETT and JUSTIN WHITMARSH to sell narcotics to others.

It was also part of this conspiracy for KEVIN LOCKENWITZ to sell narcotics to GARY LEE LOFFLER, JENNIFER LARUE, MARK WILLARD and others.

It was also part of this conspiracy for GREGORY JAMES to supply narcotics to SEAN YOUNG, OLIVIA BENDER and others.

It was also part of this conspiracy for DEREK DENNY to sell narcotics to SEAN YOUNG, JAMES YERDON and others.

It was also part of this conspiracy for FRANCIS BURDICK to sell narcotics to JAMES LOFFLER, SEAN YOUNG and others.

It was also part of this conspiracy for FRANCIS BURDICK to obtain narcotics from DONALD JENNINGS.

It was also part of this conspiracy for DONALD JENNINGS to sell narcotics to FRANCIS BURDICK.

It was also part of this conspiracy for SONIA CRUZ to collect drug proceeds from FRANCIS BURDICK on behalf of DONALD JENNINGS.

It was also part of this conspiracy for JAMES YERDON to supply DEREK DENNY, SARAH ASHLEY, SHANE PERKINS, ROBERT BAKER, JAMIE GAINES, JORDAN GAINES, TAYLOR TERIELE and JESSIE YOUNG with narcotics to sell to others.

It was also part of this conspiracy for SHANE PERKINS, ROBERT BAKER, JONATHAN MARTINEZ and LISA DAVIS to sell narcotics to JAMES YERDON.

It was also part of this conspiracy for KENNETH YERDON and KIMBERLY LARUE to sell and transport narcotics on behalf of JAMES YERDON.

It was also part of this conspiracy for ALYSSIA PETRIE and LEE SATTLER to transport narcotics for JAMES YERDON.

It was also part of this conspiracy for JONATHAN MARTINEZ to obtain narcotics from JOSE MARCANO for sale to others.

It was also part of this conspiracy for JOSE MARCANO to sell narcotics to JONATHAN MARTINEZ and others.

It was also part of this conspiracy for NATHANIEL BIELSKI to store narcotics for JONATHAN MARTINEZ, to provide JONATHAN MARTINEZ with drug paraphernalia, and to sell narcotics.

It was also part of this conspiracy GARY BROWN, TRAVAIL MADISON, PORCHE HOUSTON, RONDELLE MOORE and COREY LEE to supply TIFFANY RICHWAY with narcotics to sell to others.

It was also part of this conspiracy for TIFFANY RICHWAY to sell narcotics to BRANDON BYLOW, JAMES YERDON, JUSTIN WHITMARSH, KAYLA FLETCHER, ROBERT KERWIN.

It was also part of this conspiracy for GARY BROWN to sell narcotics to AMY BENNETT and JUSTIN WHITMARSH.

It was also part of this conspiracy for TRAVAIL MADISON to provide narcotics to JUSTIN WHITMARSH and ROBERT KERWIN.

It was also part of this conspiracy for KAYLA FLETCHER to transport narcotics for JUSTIN WHITMARSH.

It was also part of this conspiracy for ROBERT KERWIN to sell narcotics, transport narcotics proceeds, and find lodging suitable for the sale of narcotics by TRAVAIL MADISON and TIFFANY RICHWAY.

It was also part of this conspiracy for RICHARD SIDES to obtain narcotics from RAUL BYRD to sell to others.

It was also part of this conspiracy for PORCHE HOUSTON to transport narcotics proceeds from TIFFANY RICHWAY to TRAVAIL MADISON.

It was also part of this conspiracy for JENNIFER ROSENBARKER, RAUL BYRD, RICHARD LAPLANT and JENELLE PARKER to provide lodging from which TIFFANY RICHWAY sold narcotics.

It was also part of this conspiracy for RICHARD SIDES to transport narcotics for TIFFANY RICHWAY.

It was also part of the conspiracy for members of the conspiracy to communicate with each other and others over cellular telephones using codes and speaking in a guarded, cryptic manner.

# OVERT ACTS

In the furtherance of the conspiracy and to affect the objects thereof, from on or before March 4, 2016, through on or about February 17, 2017, the following overt acts, among others, were committed:

- 3. On June 28, 2016, JESSIE YOUNG sold cocaine to a person known to the Grand Jury in the City of Ogdensburg, St. Lawrence County.
- 4. On August 30, 2016, during a coded, guarded and cryptic telephone conversation, GREGORY JAMES agreed to sell cocaine to SEAN YOUNG.
- 5. On September 2, 2016, during a coded, guarded and cryptic telephone conversation, DEREK DENNY informed SEAN YOUNG that DEREK DENNY has cocaine for sale.

- 6. On September 13, 2016, during a coded, guarded and cryptic telephone conversation, FRANCIS BURDICK agreed to sell cocaine to GARY LEE LOFFLER.
- 7. On September 15, 2016, DONALD JENNINGS possessed more than one-half ounce of cocaine in the Town of Salina, Onondaga County.
- 8. On September 21, 2016, during a series of coded, guarded and cryptic telephone communications, LISA DAVIS agreed to meet JAMES YERDON at the Destiny USA Mall in the City of Syracuse, Onondaga County, for the purpose of selling cocaine to JAMES YERDON.
- 9. On September 26, 2016, during coded, guarded and cryptic telephone conversations, SONIA CRUZ directed FRANCIS BURDICK to send the proceeds of FRANCIS BURDICK's narcotics sales to an address in Bronx County.
- 10. On September 26, 2016, during a coded, guarded and cryptic telephone conversation, TAYLOR TERIELE agreed to sell heroin to a customer.
- 11. On October 13, 2016, during a coded, guarded and cryptic telephone conversation, RASUE BARNETT told GARY LEE LOFFLER that RASUE BARNETT has heroin for sale.
- 12. On October 13, 2016, during a coded, guarded and cryptic telephone conversation, SHANE PERKINS told JAMES YERDON that SHANE PERKINS has customers who want to purchase \$300 worth of narcotics.
- 13. On October 19, 2016, during a coded, guarded and cryptic telephone conversation, BARRY CRAYFORD agreed to sell cocaine to GARY LEE LOFFLER.
- 14. On October 19, 2016, during a coded, guarded and cryptic telephone conversation, SARAH ASHLEY ordered cocaine from GARY LEE LOFFLER to sell to others.
- 15. On October 20, 2016, in a series of coded, guarded and cryptic telephone conversations, JENNIFER KERR agreed to sell cocaine to GARY LEE LOFFLER.

- 16. On October 22, 2016, in a series of coded, guarded and cryptic telephone conversations, KEVIN LOCKENWITZ offered to sell five bundles of heroin to GARY LEE LOFFLER.
- 17. On October 25, 2016, during a coded, guarded and cryptic telephone conversation, JAMES YERDON told TIFFANY RICHWAY that a portion of the heroin TIFFANY RICHWAY sold to JAMES YERDON is missing.
- 18. On October 26, 2016, during a series of coded, guarded and cryptic telephone conversations BRANDON BYLOW ordered cocaine from TIFFANY RICHWAY to sell to others.
- 19. On October 27, 2016, during a coded, guarded and cryptic telephone conversation JOSHUA SEIDEL offered to sell heroin to GARY LOFFLER in the City of Ogdensburg, St. Lawrence County.
- 20. On October 29, 2016, during a coded, guarded and cryptic telephone conversation, DARREN ST. GERMAIN agreed to sell cocaine to GARY LEE LOFFLER.
- 21. On October 31, 2016, during a coded, guarded and cryptic telephone conversation, KENNETH YERDON told JAMES YERDON where KENNETH YERDON had hidden JAMES YERDON's cocaine.
- 22. On November 2, 2016, during a coded, guarded and cryptic telephone conversation, MARK WILLARD agreed to sell heroin to GARY LEE LOFFLER.
- 23. On November 8, 2016, during a coded, guarded and cryptic telephone conversation, ROBERT KERWIN agreed to transport narcotic proceeds from TIFFANY RICHWAY in St. Lawrence County to TRAVAIL MADISON in Monroe County.
- 24. On November 10, 2016, PORCHE HOUSTON delivered cocaine and heroin to TIFFANY RICHWAY in the Village of Gouverneur, St. Lawrence County.

- 25. On November 12, 2016, during a coded, guarded and cryptic telephone conversation, ROBERT BAKER offered to trade the narcotics Oxycodone and Subutex to JAMES YERDON in exchange for cocaine.
- 26. On November 13, 2016, in a series of coded, guarded and cryptic telephone communications, GARY LEE LOFFLER offered to sell heroin to JENNIFER LARUE.
- 27. On November 14, 2016, during a coded, guarded and cryptic telephone conversation, MARIANO PATTERSON agreed to sell heroin to GARY LEE LOFFLER.
- 28. On November 21, 2016, in a series of coded, guarded and cryptic telephone conversations, JORDAN GAINES ordered heroin from JAMES YERDON to sell to others.
- 29. On November 25, 2016, during a series of coded, guarded and cryptic telephone communications, JENNIFER LARUE agreed to sell cocaine to GARY LEE LOFFLER.
- 30. On November 27, 2016, during a series of coded, guarded and cryptic telephone conversations, JOSE MARCANO and JONATHAN MARTINEZ discussed the quality of the heroin they were selling.
- 31. On December 7, 2016, during a coded, guarded and cryptic telephone conversation, JENNIFER ROSENBARKER warned TRAVAIL MADISON that the residence she had provided TRAVAIL MADISON to possess and sell narcotics from is under police scrutiny.
- 32. On December 30, 2016, during a coded, guarded and cryptic telephone conversation, RAUL BYRD told GARY BROWN that RAUL BYRD had found a new location in Gouverneur, St. Lawrence County, New York, from which TIFFANY RICHWAY can sell narcotics.

- 33. On December 31, 2016, in a coded, guarded and cryptic telephone conversation, AMY BENNETT ordered heroin from TRAVAIL MADISON to sell to others and TRAVAIL MADISON told AMY BENNETT that the price of heroin has gone up.
- 34. From on or about December 31, 2016, through January 7, 2017, RICHARD LAPANT and JANELLE PARKER allowed TIFFANY RICHWAY to sell narcotics from their apartment in the Village of Gouverneur, St. Lawrence County.
- 35. On January 5, 2017, RONDELLE MOORE delivered heroin to TIFFANY RICHWAY in the Village of Gouverneur, New York.
- 36. On January 7, 2017, RICHARD SIDES transported TIFFANY RICHWAY, as well as narcotics and narcotics proceeds, from a residence in the Village of Gouverneur, St. Lawrence County.
- 37. On January 7, 2017, TIFFANY RICHWAY possessed heroin more than eight ounces of cocaine in the Village of Gouverneur, St. Lawrence County.
- 38. On January 7, 2017, in a coded, guarded and cryptic telephone conversation, RAUL BYRD agreed to sell cocaine to a customer.
- 39. On January 11, 2017, in a coded, guarded and cryptic telephone conversation JAMIE BONANNO ordered three grams of cocaine from GARY BROWN to sell to others.
- 40. On January 14, 2017, JUSTIN WHITMARSH and KAYLA FLETCHER possessed a controlled substance that subsequently tested positive for the presence of Fentanyl, Tramadol and Ketamine in Antwerp, Jefferson County.
- 41. On January 14, 2017, in a series of coded, guarded and cryptic telephone communications, JAMES YERDON ordered cocaine from JONATHAN MARTINEZ to sell to others.

- 42. On January 14, 2017, ALYSSIA PETRIE possessed more than one-half ounce of cocaine in the Town of Hammond, St. Lawrence County.
- 43. On January 14, 2017, LEE SATTLER possessed more than one-half ounce of cocaine in the Town of Hammond, St. Lawrence County.
- 44. On January 15, 2017, COREY LEE delivered narcotics to TIFFANY RIDGEWAY at the Town of Pamelia, Jefferson County.
- 45. On January 17, 2017, JAMIE GAINES sold cocaine to a person known to the Grand Jury in the City of Ogdensburg, St. Lawrence County, New York.
- 46. On February 17, 2017, NATHANIEL BIELSKI possessed heroin, as well as assorted drug paraphernalia, in the City of Syracuse, Onondaga County.
- 47. On March 17, 2016, SEAN YOUNG sold cocaine to a person known to the Grand Jury in the City of Ogdensburg, St. Lawrence County.

# **COUNT TWO**

AND THE AFORESAID GRAND JURY by this indictment further accuses the defendant, JENNIFER LARUE, of the crime of **CRIMINAL SALE OF A CONTROLLED SUBSTANCE**IN THE THIRD DEGREE in violation of Section 220.39(1) of the Penal Law of the State of New York committed as follows:
