

Detective Supervisor – Organized Crime Task Force, Albany

The Office of the Attorney General (OAG) is seeking qualified candidates for a Detective Investigator position in the above noted location. Candidates should be hard working, motivated and committed to public service on behalf of the people of the State of New York.

The role of the OCTF is to conduct complex, long-term investigations into various types of organized criminal activity. The majority of the Unit's investigations utilize advanced and specialized investigative techniques such as physical surveillance; court authorized eavesdropping of telephones, businesses, vehicles, and computers, as well as search warrants, which include the use of still and video photography. The nature of the investigations conducted by OCTF includes traditional organized crime - gambling, loan sharking, extortion, narcotics and gun trafficking, among others.

The qualifications for this position are: At least ten years of law enforcement service in the Albany/Capitol region of the state, with strong emphasis on investigative experience; ability to effectively manage multiple investigations in a variety of disciplines; experience writing and reviewing case reports; experience in supervising field operations such as search warrants and arrests; experience conducting self-initiated and internal investigations; coordination with other law enforcement agencies, and working in a multi-agency task force environment.

Preferred qualifications: A background of supervisory experience, either in law enforcement or in military service, which would enable a candidate to lead others in a team-oriented environment; interview and interrogation skills; proficiency in the use of electronic surveillance equipment; expertise in collection of evidence and executing search and arrest warrants; extensive experience in illegal narcotics enforcement, gun trafficking investigations, organized crime, and other complex criminal enterprise investigations. The ideal candidate will also have training and experience in conducting and leading dynamic enforcement operations; as well as possess experience testifying in various courts and have established contacts at the city, state and federal levels within the law enforcement community serving the greater Albany area.
