

## Investigator: Investigations – Poughkeepsie

The Office of the Attorney General is seeking qualified candidates for Investigator positions located in various locations in the State. Candidates should be hard-working, motivated and committed to public service on behalf of the people of the State of New York.

Investigators, under supervision, conduct detailed investigations of the circumstances, facts and conditions connected with complaints and violations of the law, using the highest level of independent judgment and discretion. These are often highly complex and sensitive criminal matters which cross county and state lines. This position assists the Dignitary Protection Detail for the Attorney General on an as-needed basis and conducts investigations in a wide variety of criminal cases in various bureaus throughout the Office of the Attorney General.

The qualifications for this specific position include: **A Bachelor's degree; experience conducting protection operations ensuring the security of high level officials and other dignitaries; experience in threat assessment, protective intelligence and logistical security planning and travel; familiarization with evacuation routes; and experience implementing proper steps to eliminate and/or reduce risks including threats and hazards. While this position is assigned to the Poughkeepsie area, the incumbent must be available to travel anywhere the Attorney General travels, at any time. Other qualifications include previous investigative experience in sex-related crimes, experience in surveillance operations, interaction and coordination with other law enforcement agencies, having law enforcement contacts in the Dutchess and surrounding counties area.**

### **Qualifications in addition to those listed above:**

Must have at least ten years of law enforcement and current NYS basic police school certification.

Must possess a valid NYS driver's license and have the ability to drive a motor vehicle.

The Public Officer's Law requires that police officers at the OAG be citizens of the United States and reside in New York State.

Performance of the duties may require frequent, unscheduled work on evenings and weekends.
