FIRST COUNT

THE GRAND JURY OF THE COUNTY OF BRONX, BY THIS INDICTMENT,
ACCUSES THE DEFENDANT DION MIDDLETON OF THE CRIME OF MURDER IN THE SECOND
DEGREE, COMMITTED AS FOLLOWS:

THE DEFENDANT, DION MIDDLETON, ON OR ABOUT JULY 21, 2022, IN THE COUNTY
OF BRONX, WITH INTENT TO CAUSE THE DEATH OF A PERSON, DID CAUSE THE
DEATH OF RAYMOND CHALUISANT, BY SHOOTING HIM WITH A LOADED FIREARM.

SECOND COUNT

THE GRAND JURY OF THE COUNTY OF BRONX, BY THIS INDICTMENT,
ACCUSES THE DEFENDANT DION MIDDLETON OF THE CRIME OF MANSLAUGHTER IN THE FIRST
DEGREE, COMMITTED AS FOLLOWS:

THE DEFENDANT, DION MIDDLETON, ON OR ABOUT JULY 21, 2022, IN THE COUNTY
OF BRONX, DID CAUSE THE DEATH OF RAYMOND CHALUISANT, WHILE ACTING WITH INTENT
TO CAUSE SERIOUS PHYSICAL INJURY TO THAT PERSON, BY SHOOTING HIM WITH A LOADED
FIREARM.

THIRD COUNT

THE GRAND JURY OF THE COUNTY OF BRONX, BY THIS INDICTMENT,
ACCUSES THE DEFENDANT DION MIDDLETON OF THE CRIME OF MANSLAUGHTER IN THE SECOND
DEGREE, COMMITTED AS FOLLOWS:

THE DEFENDANT, DION MIDDLETON, ON OR ABOUT JULY 21, 2022, IN THE COUNTY
