**FINAL DECREE OF
JUDICIAL SETTLEMENT
FOR ADMINISTRATOR**

A petition praying for a decree judicially settling the final account having been presented and filed in this court and the time to present claims against the estate having expired, and a citation returnable on November 3, 2022 having been issued directed to all persons interested in this proceeding requiring them to show cause why a decree should not be granted judicially settling the account prayed for in the petition, and the citation having been returned with proof of due service thereof on the following:

AND the following intestate distributees having appeared in answer to the citation: Barbara Price, Barry Price, Meryl Newman Berk, Jadwiga Kaminska, Ilana Alexandroni a/k/a Helena Ilana Kaminska, Dana Nahum, David Ross, as Executor of the Estate of Robert Ross a/k/a Robert Martin Rosenblum, Barry Schneider, Victoria Albrecht a/k/a Harriet Victoria Bender, Myra Bender, Myra Bender, as Executor of the Estate of Maureen Lois Bender, and Kenneth Wohl by their attorney, Jeff M. Fried, Esq., New York State Department of Taxation and Finance having appeared by Eileen Davies, and the Attorney General of the State of New York having appeared by Judith Woods, Esq., and Timothy E. Ladin, Esq. having appeared for the Price Family Foundation, Inc.;

AND Gary S. Basso, Esq., having appeared for the petitioner, and there being no other appearances;

AND it appearing that a Stipulation of Settlement dated May 4, 2026, has been entered into by and among the Public Administrator of Bronx County, Jeffrey M. Fried, Esq. on behalf of the intestate distributees, the Price Family Foundation, Inc., and the New York State Office of the Attorney General, resolving all objections to the account and setting forth the terms of distribution of the estate;

AND it appearing that all tax returns required by law have been filed and all New York State estate taxes have been fully paid, provision made therefore, or the estate is exempt from tax;

AND the Surrogate having examined the account as amended and updated, and having found that the petitioner has fully accounted for all of the monies and property of the estate that have come into the petitioner's hands for the period of the account, as adjusted, it is

ORDERED, ADJUDGED AND DECREED, that the final account as amended and updated be and the same hereby is judicially settled and allowed as filed (and adjusted), and that the following is a summary thereof as settled:

AND IT IS FURTHER ORDERED that the Stipulation of Settlement dated May 4, 2026 entered into among the parties be and hereby is incorporated in its entirety with this decree and it is further

ORDERED, ADJUDGED, AND DECREED, that the petitioner shall retain the sum of \$62,375.00 as determined necessary for the payment of any additional liabilities of the estate, including but not limited to any remaining income tax liability, accounting fees, and return preparation fees of Glatt, Maney, Kling & Rufer, CPA's, PC and accounting fees for estate tax returns of Denise M. Knight, CPA the sum of \$30,000, in the total amount of \$92,375.00 and upon the final settlement of such liabilities, is directed to pay the balance then remaining to the Price Family Foundation

Ordered, Adjudged and Decreed, that it having previously been determined that the Decedent's next of kin are Barbara Price, Barry Price, Meryl Newman Berk, Jadwiga Kaminska, Ilana Alexandroni a/k/a Helena Ilana Kaminska, Dana Nahum, David Ross, as Executor of the Estate of Robert Ross a/k/a Robert Martin Rosenblum, Barry Schneider, Victoria Albrecht a/k/a Harriet Victoria Bender, Myra Bender, Myra Bender, as Executor of the Estate of Maureen Lois Bender, and Kenneth Wohl, and the parties having stipulated that the residuary beneficiary under

the Last Will and Testament of the decedent is the Price Family Foundation, Inc., the petitioner shall distribute the balance remaining on hand as follows:

1. To: the Commissioner of Finance of the City of New York, as and for commissions earned by the petitioner pursuant to SCPA 2307 and 1106(1) & (2), the sum of \$203,218.64, and
2. To: the Public Administrator, Bronx County, pursuant to SCPA 1106(3), for the balance of the Statutory Imprest Fee, the sum of \$55,328.01; and
3. To: Gary S. Basso, Esq., Velella & Basso, as and for legal fees earned and outstanding, the sum of \$137,847.35, and
4. To: NYC Human Resources Administration for the balance of Medicaid provided to Herman Price the sum of \$33,167.43; and
5. To: NYC Human Resources Administration to Morton Price to be paid by the Estate of Herman Price as beneficiary of the Estate of Morton Price the sum of \$1,874.41; and
6. To: Jeffrey M. Fried, Esq. as attorney for the intestate distributees, collectively, in accordance with the Stipulation of Settlement dated May 4, 2026, the sum of Three Million Five Hundred Thousand Dollars (\$3,500,000.00), and
7. To: the nine (9) Bronx charitable organizations identified on Schedule A of the Stipulation of Settlement, in accordance with the Stipulation of Settlement dated May 4, 2026, the sum of Two Hundred Fifty Thousand Dollars (\$250,000.00) each, for an Initial Charitable Distribution total of Two Million Two Hundred Fifty Thousand Dollars (\$2,250,000.00), plus an additional Residual Charitable Distribution of Fifty Thousand Dollars (\$50,000.00) each, for a total per charity of Three Hundred Thousand Dollars (\$300,000.00), and

8. To Rachael A. Harding Esq., as and for her fee as Guardian Ad Litem the sum of
\$ 7,315.00

9. The balance of the net distributable estate to the Price Family Foundation, Inc., in
accordance with the Stipulation of Settlement dated May 4, 2026; and it is further

ORDERED, ADJUDGED AND DECREED, that the Will construction proceeding (File
No. 2017-2243/D) is hereby dismissed as moot, and it is further

ORDERED, ADJUDGED AND DECREED, that upon complying with the directions of
this decree and the filing of proof of service of a copy of this Order with Notice of Entry, the
petitioner hereby shall be discharged as to all matters and things contained in this accounting, as
adjusted, and this decree.
