### **FIRST COUNT**

THE GRAND JURY OF THE COUNTY OF KINGS BY THIS INDICTMENT, ACCUSES THE DEFENDANT, YVONNE WU, OF THE CRIME OF MURDER IN THE FIRST DEGREE [PL 125.27(1)(A)(VII)] COMMITTED AS FOLLOWS:

THE DEFENDANT, YVONNE WU, ON OR ABOUT OCTOBER 13, 2021, IN THE COUNTY OF KINGS, WITH THE INTENT TO CAUSE THE DEATH OF JAMIE LIANG, DEFENDANT CAUSED THE DEATH OF JAMIE LIANG, WHILE THE DEFENDANT WAS IN THE COURSE OF COMMITTING OR ATTEMPTING TO COMMIT, OR IN THE IMMEDIATE FLIGHT THEREFROM, AND IN FURTHERANCE OF BURGLARY IN THE FIRST DEGREE, WHEREAS JAMIE LIANG WAS NOT A PARTICIPANT IN THE BURGLARY, AND THE DEFENDANT WAS MORE THAN EIGHTEEN YEARS OLD AT THE TIME OF THE COMMISSION OF THE CRIMES.

### **SECOND COUNT**

THE GRAND JURY OF THE COUNTY OF KINGS BY THIS INDICTMENT, ACCUSES THE DEFENDANT, YVONNE WU, OF THE CRIME OF MURDER IN THE SECOND DEGREE [PL 125.25(1)] COMMITTED AS FOLLOWS:

THE DEFENDANT, YVONNE WU, ON OR ABOUT OCTOBER 13, 2021, IN THE COUNTY OF KINGS, WITH THE INTENT TO CAUSE THE DEATH OF JAMIE LIANG, DEFENDANT, YVONNE WU, CAUSED THE DEATH OF JAMIE LIANG.

### **THIRD COUNT**

THE GRAND JURY OF THE COUNTY OF KINGS BY THIS INDICTMENT, ACCUSES THE DEFENDANT, YVONNE WU, OF THE CRIME OF ATTEMPTED MURDER IN THE FIRST DEGREE [PL 110/125.27(1)(A)(VII)] COMMITTED AS FOLLOWS:

THE DEFENDANT, YVONNE WU, ON OR ABOUT OCTOBER 13, 2021, IN THE COUNTY OF KINGS, WITH THE INTENT TO CAUSE THE DEATH OF JENNY LI, DEFENDANT ATTEMPTED TO CAUSE THE DEATH OF JENNY LI, WHILE THE DEFENDANT WAS IN THE COURSE OF COMMITTING OR ATTEMPTING TO COMMIT, OR IN THE IMMEDIATE FLIGHT THEREFROM, AND IN FURTHERANCE OF BURGLARY IN THE FIRST DEGREE, WHEREAS JENNY LI WAS NOT A PARTICIPANT IN THE BURGLARY, AND THE DEFENDANT WAS MORE THAN EIGHTEEN YEARS OLD AT THE TIME OF THE COMMISSION OF THE CRIMES.

### **FOURTH COUNT**

THE GRAND JURY OF THE COUNTY OF KINGS BY THIS INDICTMENT, ACCUSES THE DEFENDANT, YVONNE WU, OF THE CRIME OF ATTEMPTED MURDER IN THE SECOND DEGREE [PL 110/125.25(1)] COMMITTED AS FOLLOWS:

THE DEFENDANT, YVONNE WU, ON OR ABOUT OCTOBER 13, 2021, IN THE COUNTY OF KINGS, WITH THE INTENT TO CAUSE THE DEATH OF JENNY LI, DEFENDANT ATTEMPTED TO CAUSE THE DEATH OF JENNY LI.

### **FIFTH COUNT**

THE GRAND JURY OF THE COUNTY OF KINGS BY THIS INDICTMENT, ACCUSES THE DEFENDANT, YVONNE WU, OF THE CRIME OF ASSAULT IN THE FIRST DEGREE [PL 120.10(1)] COMMITTED AS FOLLOWS:

THE DEFENDANT, YVONNE WU, ON OR ABOUT OCTOBER 13, 2021, IN THE COUNTY OF KINGS, WITH INTENT TO CAUSE SERIOUS PHYSICAL INJURY TO JENNY LI, DEFENDANT CAUSED SERIOUS PHYSICAL INJURY TO JENNY LI BY MEANS OF A DEADLY WEAPON OR A DANGEROUS INSTRUMENT, NAMELY: A PISTOL.

**SIXTH COUNT**

THE GRAND JURY OF THE COUNTY OF KINGS BY THIS INDICTMENT, ACCUSES DEFENDANT, YVONNE WU, OF THE CRIME OF BURGLARY IN THE FIRST DEGREE [PL 140.30(2)] COMMITTED AS FOLLOWS:

THE DEFENDANT, YVONNE WU, ON OR ABOUT OCTOBER 13, 2021, IN THE COUNTY OF KINGS, KNOWINGLY ENTERED OR REMAINED UNLAWFULLY IN A DWELLING BELONGING TO ANOTHER PERSON AS CUSTODIAN WITH INTENT TO COMMIT A CRIME THEREIN AND IN EFFECTING ENTRY OR WHILE IN THE DWELLING OR IN IMMEDIATE FLIGHT THEREFROM, THE DEFENDANT CAUSED PHYSICAL INJURY TO A PERSON WHO WAS NOT A PARTICIPANT IN THE CRIME, NAMELY: JAMIE LIANG.

**SEVENTH COUNT**

THE GRAND JURY OF THE COUNTY OF KINGS BY THIS INDICTMENT, ACCUSES DEFENDANT, YVONNE WU, OF THE CRIME OF BURGLARY IN THE FIRST DEGREE [PL 140.30(2)] COMMITTED AS FOLLOWS:

THE DEFENDANT, YVONNE WU, ON OR ABOUT OCTOBER 13, 2021, IN THE COUNTY OF KINGS, KNOWINGLY ENTERED OR REMAINED UNLAWFULLY IN A DWELLING BELONGING TO ANOTHER PERSON AS CUSTODIAN WITH INTENT TO COMMIT A CRIME THEREIN AND IN EFFECTING ENTRY OR WHILE IN THE DWELLING OR IN IMMEDIATE FLIGHT THEREFROM, THE DEFENDANT CAUSED PHYSICAL INJURY TO A PERSON WHO WAS NOT A PARTICIPANT IN THE CRIME, NAMELY: JENNY LI.

**EIGHTH COUNT**

THE GRAND JURY OF THE COUNTY OF KINGS BY THIS INDICTMENT, ACCUSES DEFENDANT, YVONNE WU, OF THE CRIME OF BURGLARY IN THE FIRST DEGREE [PL 140.30(1)] COMMITTED AS FOLLOWS:

THE DEFENDANT, YVONNE WU, ON OR ABOUT OCTOBER 13, 2021, IN THE COUNTY OF KINGS, KNOWINGLY ENTERED OR REMAINED UNLAWFULLY IN A DWELLING BELONGING TO ANOTHER PERSON AS CUSTODIAN WITH INTENT TO COMMIT A CRIME THEREIN AND IN EFFECTING ENTRY OR WHILE IN THE DWELLING OR IN IMMEDIATE FLIGHT THEREFROM, THE DEFENDANT WAS ARMED WITH A DEADLY WEAPON, NAMELY: A PISTOL.
